4 **AN ORDINANCE APPROPRIATING MONIES FOR THE**
5 **PURPOSE OF DEFRAYING THE EXPENSES OF THE**
6 **SEVERAL DEPARTMENTS OF THE CITY GOVERNMENT**
7 **OF THE CITY OF FORT WAYNE, INDIANA, FOR THE**
8 **FISCAL YEAR BEGINNING JANUARY 1, 2012, AND**
9 **ENDING DECEMBER 31, 2012, INCLUDING ALL**
10 **OUTSTANDING CLAIMS AND OBLIGATIONS AND FIXING**
11 **A TIME WHEN THE SAME SHALL TAKE EFFECT.**

12 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON**
13 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

14 **SECTION 1.** That for the expenses of the City Government
15 and its institutions for the year ending December 31, 2012, the sums of
16 money shown on Budget Form 4-A are hereby appropriated and ordered set
17 apart out of the several funds herein named and for the purposes herein
18 specified, subject to the laws governing the same. Such sums herein
19 appropriated shall be held to include all expenditures authorized to be made
20 during the year, unless otherwise expressly stipulated and provided by law.
21 In addition, for the purpose of raising revenue to meet the necessary
22 expenses of City Government, tax rates are shown on Budget Form 4-B and
23 included herein. Form 4-A and 4-B for all funds and departments for fiscal
24 2012 are incorporated herein by reference. Two (2) copies of fiscal 2012
25 Form 4-A and Form 4-B are on file and available for public inspection in the
26 office of the Clerk of the City of Fort Wayne, as required by I.C. 36-1-5-4.

27 **SECTION 2.** That this Ordinance shall be in full force and
