2 APPROPRIATION ORDINANCE NO. A- 4-12

3 AN ORDINANCE APPROPRIATING MONIES FOR THE
4 PURPOSE OF DEFRAYING THE EXPENSES OF FORT
5 WAYNE PUBLIC TRANSPORTATION, FOR THE FISCAL
6 YEAR BEGINNING JANUARY 1, 2013, AND ENDING
7 DECEMBER 31, 2013, INCLUDING ALL OUTSTANDING
CLAIMS AND OBLIGATIONS AND FIXING A TIME WHEN
THE SAME SHALL TAKE EFFECT.

8 NOW, THEREFORE, BE IT ORDAINED BY THE COMMON
9 COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

10 SECTION 1. That for the expenses of Fort Wayne Public
11 Transportation for the year ending December 31, 2013, the sums of money
12 shown on Budget Form 4-A are hereby appropriated and ordered set apart
13 out of the several funds herein named and for the purposes herein specified,
14 subject to the laws governing the same. Such sums herein appropriated
15 shall be held to include all expenditures authorized to be made during the
16 year, unless otherwise expressly stipulated and provided by law. In addition,
17 for the purpose of raising revenue to meet the necessary expenses of Fort
18 Wayne Public Transportation, tax rates are shown on Budget Form 4-B and
19 included herein. Form 4-A and 4-B for all funds for fiscal 2013 are
20 incorporated herein by reference. Two (2) copies of fiscal 2013 Form 4-A
21 and Form 4-B are on file and available for public inspection in the office of
22 the Clerk of the City of Fort Wayne, as required by I.C. 36-1-5-4.










ORDINANCE / RESOLUTION FOR APPROPRIATIONS AND TAX RATE

Ordinance / Resolution Number:

Be it ordained / resolved by the **City of Fort Wayne City Council** that for the expenses of **FORT WAYNE PUBLIC TRANSPORTATION**, Indiana for the year ending December 31, 2013 the sum of **\$13,197,869** as shown on Budget Form 4-A are hereby appropriated and ordered set apart out of the funds herein named and for the purposes herein specified, subject to the laws governing the same. Such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided for by law. In addition, for the purposes of raising revenue to meet the necessary expense of **FORT WAYNE PUBLIC TRANSPORTATION**, a total property tax levy of **\$5,171,959** and a total tax rate of **0.0665**, are adopted as shown on Budget Form 4-B and included herein. Budget Form 4-A and 4-B for all funds and departments are incorporated by the signing of this form and must be completed and submitted in the manner prescribed by the Department of Local Government Finance.

This ordinance / resolution shall be in full force and effect from and after its passage and approval by the taxing **City of Fort Wayne City Council**.
