3 **APPROPRIATION ORDINANCE NO. A- 5-12**

4 **AN ORDINANCE appropriating monies into certain**  
5 **accounts for the 2012 Budgets of various funds and**  
6 **departments of the City of Fort Wayne, reducing the**  
7 **unappropriated and unobligated balance of the**  
8 **particular fund involved as required to meet obligations**  
9 **for the remainder of 2012.**

10 **WHEREAS**, the budget adjustment policy of the City of Fort Wayne  
11 stipulates that all Departments operating on a tax supported and/or City Council approved  
12 budget shall submit requests to the Controller for appropriation of additional monies to the  
13 2012 budgets to provide sufficient operating funds for the remainder of 2012;

14 **WHEREAS**, adequate funds exist in the unappropriated and unobligated  
15 balance of the funds specified and in the appropriations of certain departments as specified;


16 **WHEREAS**, such appropriations have been recommended by the City
