10 NOW, THEREFORE, BE IT ORDAINED BY THE COMMON
11 COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

13 SECTION 1. That for the expenses of the City Government and its
14 institutions for the year ending December 31, 2021, the sums of money shown in
15 the 2021 Operating Budget Book are hereby appropriated and ordered set apart
16 out of the several funds herein named and for the purposes herein specified,
17 subject to the laws governing the same. Such sums herein appropriated shall be
18 held to include all expenditures authorized to be made during the year, unless
19 otherwise expressly stipulated and provided by law. Two (2) copies of the 2021
20 Operating Budget Book are on file and available for public inspection in the office of
21 the Clerk of the City of Fort Wayne, as required by I.C. 36-1-5-4.

23 SECTION 2. That this Ordinance shall be in full force and effect from
24 and after its passage and approval by the Common Council, and any and all
25 necessary approval by the Mayor, legal publication thereof, and is subject to the
26 laws of the State of Indiana governing appropriations.
