5 GENERAL ORDINANCE NO. G- 38-11

6 **AN ORDINANCE amending the Thoroughfare**
7 **Plan of the City Comprehensive ("Master")**
8 **Plan by vacating public right-of-way.**

9 WHEREAS, a petition to vacate public right-of-way within the City of Fort Wayne, Indiana, (as
10 more specifically described below) was duly filed with the City Clerk of the City of Fort Wayne,
11 Indiana; and

12 WHEREAS, Common Council of the City of Fort Wayne, Indiana, duly held a public hearing
13 and approved said petition, as provided in I.C. 36-7-3-12.

14 NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF
15 FORT WAYNE, INDIANA:

16 SECTION 1. That the petition filed herein to vacate a public right-of-way within the City of
17 Fort Wayne, Indiana, more specifically described as follows, to-wit:

18 The fifty-foot wide right-of-way of Woodway Drive, located between Lots 189 and 190 of Royal
19 Oak Park Addition, Section B, as recorded in Deed Book 23, page 20 in the Office of the
20 Recorder, Allen County, Indiana, more particularly described as follows:

21 Beginning at the Southeast corner of Lot 189 of Royal Oak Park Addition, Section B, as recorded
22 in Deed Book 23, page 20 in the Office of the Recorder, Allen County, Indiana; thence northerly, a
23 distance of approximately 161 feet, to the Northeast corner of Lot 189 of said addition; thence
24 easterly, a distance of 50 feet, to the Northwest corner of Lot 190 of said addition; thence
25 southerly, a distance of approximately 162 feet, to the Southwest corner of Lot 190 in said
26 addition; thence westerly, a distance of fifty feet, to the Point of Beginning, containing 0.186
27 acres, more or less.

28 and which vacating amends the Thoroughfare Plan of the City Comprehensive ("Master") Plan
29 and is hereby approved in all respects.

30 SECTION 2. That this Ordinance shall be in full force and effect from and after its passage,
any and all necessary approval by the Mayor.
