GENERAL ORDINANCE NO. G- 13-11

**AN ORDINANCE amending the Thoroughfare
Plan of the City Comprehensive ("Master")
Plan by vacating public right-of-way.**

WHEREAS, a petition to vacate public right-of-way within the City of Fort Wayne, Indiana, (as more specifically described below) was duly filed with the City Clerk of the City of Fort Wayne, Indiana; and

WHEREAS, Common Council of the City of Fort Wayne, Indiana, duly held a public hearing and approved said petition, as provided in I.C. 36-7-3-12.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:


SECTION 1. That the petition filed herein to vacate a public right-of-way within the City of Fort Wayne, Indiana, more specifically described as follows, to-wit:

The 10 foot wide east-west alley right-of-way located on the north side of Lot 134 in Ormiston Heirs' Addition to the City of Fort Wayne, as recorded in Deed Book 145, page 44, in the Office of the Recorder of Allen County, Indiana, more particularly described as follows:

Beginning at the northeast corner of said Lot 134 in Ormiston Heirs' Addition; thence north a distance of 10.0 feet along the west right-of-way line of South Lafayette Street; thence west a distance of 107.0 feet parallel to the north line of said Lot 134 in Ormiston Heirs' Addition; thence south a distance of 10.0 feet parallel to the right-of-way of South Lafayette Street to a point on the north property line of said Lot 134 in Ormiston Heirs' Addition; thence east a distance of 107.0 feet along the north property line of said Lot 134 in Ormiston Heirs' Addition to the point of beginning, containing 1,070 square feet of land, more or less.

and which vacating amends the Thoroughfare Plan of the City Comprehensive ("Master") Plan and is hereby approved in all respects.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage, any and all necessary approval by the Mayor.


