GENERAL ORDINANCE NO. G- 11-11

AN ORDINANCE AMENDING SECTION 153.11 OF
CHAPTER 153 "PLANNING & DEVELOPMENT" OF
THE CITY OF FORT WAYNE, INDIANA, CODE OF
ORDINANCES.

WHEREAS, Common Council of the City of Fort Wayne adopted a Comprehensive Plan for the City of Fort Wayne (Plan-it Allen), in accordance with the statutes of the State of Indiana; and,

WHEREAS, on November 23, 2010, the Common Council adopted Resolution No. R-46-10, which initiated the amendment to the Comprehensive Plan to include the goals and policies of the Walk Fort Wayne Plan, to be adopted; and,

WHEREAS, the Common Council desires to amend Section 153.11 to recognize the Amendment to the Comprehensive Plan; and,

WHEREAS, the City Plan Commission in accordance with the Planning Statutes of the State of Indiana held a public hearing on the Amendment to the Comprehensive Plan; and,

WHEREAS, this ordinance is to establish an amendment to the Comprehensive Plan to include the goals and policies of the Walk Fort Wayne Plan to be adopted.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. Section 153.11 of Chapter 153 (Planning & Development) of the Code of the City of Fort Wayne is amended by adding the following subsection (O):

(O) Walk Fort Wayne Plan. The Comprehensive Plan (Plan-it Allen) is amended by adding the goals and policies of the "Walk Fort Wayne Plan" as set forth in that plan.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
