ORDINANCE NO. G- 11- 11

**AN ORDINANCE AMENDING SECTION 32.55,
NUMBERING SYSTEM PRIOR TO INTRODUCTION,
OF THE FORT WAYNE CODE OF ORDINANCES
TO ADD AN ADDITIONAL SECTION E CONCERNING
A NUMBERING AND INDEXING SYSTEM WITH REGARD TO
INTERNAL COUNCIL POLICIES, STAFF APPOINTMENTS,
AND PROCEDURES**

WHEREAS, Common Council is called upon regularly to take action on internal procedures, its staff, and/or to make or confirm appointments to government boards and commissions; and

WHEREAS, in undertaking this action a record is made of such action; and

WHEREAS, it is important for the City to continue to find efficiencies with regard to the recordkeeping pertaining to such matters; and

WHEREAS, ease of transparency for the citizens of Fort Wayne is also a consideration; and

WHEREAS, creating a numbering and indexing system with regard to the aforementioned internal procedures for Council, its staff and/or its appointments to commissions would help to serve all of the foregoing purposes.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

Section 1. The Fort Wayne Code of Ordinance at Section 32.55, Numbering System Prior to Introduction, shall be amended to add a section E as follows:


E. Any proposal which contemplates action relating only to the internal procedures of a council, its staff, or relates to appointment or confirmation of appointments made exclusively by the council, shall be designated "a proposal for a council resolution." The proposal shall be properly before the council for final action at the same meeting at which it is introduced, unless the president or the council refers or postpones the proposal.

The Clerk of the Council shall designate each such proposal when passed by a majority vote of council as a Special Council Resolution and shall distinguish each such Special Council Resolution by a serial


numbering system which is first denominated by year and then by sequential number.

Section 2. That this Ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.
