4 GENERAL ORDINANCE NO. G- 18-11 Plat Book: 42, Page No: 140

5 AN ORDINANCE amending the Thoroughfare
6 Plan of the City Comprehensive ("Master")
7 Plan by vacating public right-of-way.

8 WHEREAS, a petition to vacate public right-of-way within the City of Fort Wayne, Indiana, (as
9 more specifically described below) was duly filed with the City Clerk of the City of Fort Wayne,
10 Indiana; and

11 WHEREAS, Common Council of the City of Fort Wayne, Indiana, duly held a public hearing
12 and approved said petition, as provided in I.C. 36-7-3-12.

13 NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF
14 FORT WAYNE, INDIANA:

15 SECTION 1. That the petition filed herein to vacate a public right-of-way within the City of
16 Fort Wayne, Indiana, more specifically described as follows, to-wit:


17 All of the alley contained in the Baptist Church Subdivision of Lot 112 of the Original Plat of the
18 Town (now City) of Fort Wayne as recorded August 31, 1866 in Book "42" page 140. Such alley
19 being 10 feet in width and being located South of Lots 1, 2 and 3, and North of Lot 4, all of said
20 Lots being contained in the Baptist Church Subdivision of Lot 112 of the Original Plat of the Town
21 (now City) of Fort Wayne as recorded August 31, 1866 in Book "42" page 140. Said alley also
22 being located East of Lot 111 and West of Clinton Street as established in the Original Plat of the
23 Town (now City) of Fort Wayne as recorded on September 30, 1840 in Book "D" page 169.

24 and which vacating amends the Thoroughfare Plan of the City Comprehensive ("Master") Plan
25 and is hereby approved in all respects.

26 SECTION 2. That this Ordinance shall be in full force and effect from and after its passage,
27 any and all necessary approval by the Mayor.
