GENERAL ORDINANCE NO. G- 24-12

AN ORDINANCE AMENDING TITLE 15,
CHAPTER 156: "SWIMMING POOLS AND
BEACHES" §§156.04, AND 156.05 OF THE
CITY OF FORT WAYNE CODE OF LAWS.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON
COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That § 156.04 of Chapter 156, Title 15 of the City of Fort
Wayne, Indiana Code of Ordinances be **amended** as follows:

§ 156.04 Compliance with Zoning Code Required

No pool shall be constructed or installed unless it complies with all
applicable requirements as set forth in Chapter 157, Zoning Code.

SECTION 2. That §156.05 of Chapter 156, Title 15 of the City of Fort
Wayne, Indiana Code of ordinances be **amended** as follows:

§ 156.05 RESERVED

SECTION 3. That this Ordinance shall be in full force and effect from
