GENERAL ORDINANCE NO. G-31-12

**AN ORDINANCE AMENDING SECTION 72.22  
STOPPING, STANDING OR PARKING  
PROHIBITED IN SPECIFIED PLACES OF THE CITY  
OF FORT WAYNE, INDIANA, CODE OF  
ORDINANCES.**

**WHEREAS**, the City of Fort Wayne, Indiana has established limited free parking on the north side of Citizens Square at 200 E. Berry St., known as the Citizens Square Parking Lot; and

**WHEREAS**, improperly parked vehicles present an obstruction to citizens and others who visit Citizens Square; and

**WHEREAS**, the Fort Wayne Code of Ordinances currently provides for a parking restriction in Section 72.22, but the Board of Public Safety wishes to clarify this restriction with an Ordinance specific to the Citizens Square Parking Lot; and

**WHEREAS**, the Board of Public Safety wishes to expand and enforce the restriction in the Citizens Square Parking Lot to each vehicle being allowed a maximum of 2 hours of parking each weekday from 8 a.m. to 5 p.m.

**WHEREAS**, the Common Council of the City of Fort Wayne, Indiana has determined an amendment of § 72.22 by adding the section § 72.22 (S) furthers the interest and welfare of citizens and others who visit Citizens Square.

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

1                   **SECTION 1.** The following Section 72.22 of the City of Fort Wayne,  
2 Indiana, Code of Ordinances is hereby amended to specify and expand the  
3 parking restriction for the Citizens Square Parking Lot as follows:

4 **ADD:**

5 **§ 72.22 (S)**                   In the Citizens Square Parking Lot at 200 E. Berry St., a  
6 vehicle shall not be parked longer than a maximum time  
7 period of 2 hours each weekday from 8 a.m. to 5 p.m.

8                   **SECTION 2.** Except for the foregoing amendments, the remaining  
9 sections of Section 72.22 of the City of Fort Wayne, Indiana, Code of  
10 Ordinances shall remain in full force and effect.

11                   **SECTION 3.** This Ordinance shall be in full force and effect from and  
12 after its passage and any and all necessary approval by the Mayor.
