3 GENERAL ORDINANCE NO. G-32-12

4 AN ORDINANCE AMENDING SECTION 72.99 PENALTY –
5 TO INCLUDE SECTION 72.22(S) STOPPING, STANDING
6 OR PARKING PROHIBITED IN SPECIFIED PLACES
7 REGARDING TRAFFIC REGULATIONS OF THE CITY OF
8 FORT WAYNE, INDIANA, CODE OF ORDINANCES

9 WHEREAS, the City of Fort Wayne, Indiana (“City”) has clarified and
10 expanded an existing regulation governing the enforcement of parking
11 restrictions in the Citizens Square Parking Lot at 220 E. Berry St.; and

12 WHEREAS, Section 72.22 of the City of Fort Wayne, Indiana, Code of
13 Ordinances has been amended to include Section 72.22(S) regarding the
14 Citizens Square Parking Lot parking restrictions; and

15 WHEREAS, an amendment is necessary to establish a penalty for the
16 enforcement of Section 72.22(S) of the City of Fort Wayne, Indiana, Code of
17 Ordinances.

18 NOW, THEREFORE, BE IT ORDAINED BY THE COMMON
19 COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

20 SECTION 1. That the following Section 72.99 (A) (1) of the City of
21 Fort Wayne, Indiana, Code of Ordinances is hereby amended to include the
22 penalty for violation of the parking restriction in Citizens Square Parking Lot
23 as follows:

24 **AMEND:**

25 **§ 72.99 (A)(1)** Sections 72.22(S), 72.46 and 72.61. If the violator
26 appears in response to a notice affixed to such motor vehicle within a period
27 of 30 calendar days from the date and time shown on said notice affixed to
28 such motor vehicle, the penalty shall be \$5. If the violator fails to appear in
29 response to a notice affixed to such motor vehicle after 30 calendar days
30 from the date and time shown on said notice affixed to such motor vehicle
the penalty shall be \$10.
