**GENERAL ORDINANCE NO. 11-13**

**AN ORDINANCE AMENDING §40.03: RATIFICATION OF PRESENT RECOGNITION OF THE CITY OF FORT WAYNE, INDIANA, CODE OF ORDINANCES**

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNSEL OF THE CITY OF FORT WAYNE, INDIANA:**

**SECTION 1.** §40.03: RATIFICATION OF PRESENT RECOGNITION of the City of Fort Wayne, Indiana, Code of Ordinances Is amended as follows:

**§ 40.03 RATIFICATION OF PRESENT RECOGNITION.**

In acknowledgement of the fact the city presently recognizes and had labor agreements with six separate non-safety unions, the city does hereby ratify its recognition of these six organizations. Such organizations are deemed to be the exclusive labor representatives of the employees they represent and such exclusive recognition is ratified and confirmed. These labor organizations are: the Service Employees International Union, Local 1 (SEIU); the International Association of Machinists and Aerospace Workers, Lodge 2569 (IAM); the International Brotherhood of Electrical Workers, Local 723 (IBEW); the American Federation of State, County and Municipal Employees, Local 1384 (AFSCME); the International Union of Operating Engineers, Local 399 (IUOE); and the Chauffeurs, Teamsters, Warehousemen and Helpers, Local 414 (CTH).
