GENERAL ORDINANCE NO. G- 7-16

**ORDINANCE AMENDING SECTION 72.22 of
CHAPTER 72: STOPPING, STANDING AND
PARKING OF THE CITY OF FORT WAYNE,
INDIANA, CODE OF ORDINANCES.**

SECTION 1. That §72.22 STOPPING, STANDING OR PARKING PROHIBITED IN SPECIFIED PLACES of CHAPTER 72 of the City of Fort Wayne, Indiana, Code of Ordinances is amended as follows:

§ 72.22 STOPPING, STANDING OR PARKING PROHIBITED IN SPECIFIED PLACES.

AMEND SECTION § 72.22 T

(T) During business hours, Monday through Friday, 8:00 a.m. to 5:00 p.m., parking in the Citizens Square Parking Lot at 200 East Berry St. is authorized only when conducting business at Citizens Square. Vehicles shall not be parked longer than a maximum time period of two hours during business hours.

ADD NEW SECTION § 72.22. U

U. PRESS VEHICLE PARKING PERMIT

1. The City Clerk shall have the authority to provide local members of the Fort Wayne media with permission to park without restriction in marked media parking spaces in the Citizens Square Parking Lot at 200 East Berry St. and metered parking spaces.

2. Permission and authority for local media parking in the City of Fort Wayne shall be manifested by an appropriate permit issued by the City Clerk. The issued permit shall be hung from the rearview mirror which displays the

authorized vehicle plate number and expiration date. The cost of the permit shall be \$35.00, to be renewed annually.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage, any and all necessary approval by the Mayor.
