14 Administrative Bodies" of the Code of Ordinances of the City of Fort Wayne,
15 Indiana, is hereby amended as follows:

18 AMEND THIS SECTION AS FOLLOWS:

19 **MAYOR'S COMMISSION ON DOMESTIC VIOLENCE, RAPE**
20 **AND SEXUAL HARASSMENT**

21 **§ 33.120 ESTABLISHMENT.**

22 (A) There is hereby created a commission of municipal government
23 known as the Mayor's Commission on Domestic Violence, Rape and Sexual
24 Harassment, hereinafter referred to as the Commission.

25 **§ 33.121 PURPOSE.**

26 The purpose of the Commission is to work to deter and eradicate domestic
27 violence, rape and sexual harassment in this community. This purpose shall
28 be accomplished by:

1 (A) Implementing community-wide educational programs to assist persons
2 in becoming more aware of the high incidents of domestic violence, rape and
3 sexual harassment;

4 (B) Promoting and strengthening the interactions among agencies which
5 support victims dealing with the legal system;

6 (C) Advocating appropriate legislative and judicial reforms which hold
7 abusers accountable for their behavior; and

8 (D) Organizing all segments of the community to work together to discover
9 ways to eliminate domestic violence, rape and sexual harassment.

11 **§ 33.122 MEMBERSHIP TERMS; OFFICERS.**

12 (A) The Commission shall consist of 23 members. Membership of the
13 Commission and initial terms shall be as follows. All members shall be
14 appointed by the specific agency or entity named below. If no specific
15 agency or entity is named, the Mayor shall make the appointment.




(C) The members of the Commission shall, within 30 days after the last initial appointment is made, meet and elect a Chairperson, Vice-Chairperson and Secretary.

☐ **§ 33.121 PURPOSE.**

The purpose of the Commission is to work to deter and eradicate domestic violence, rape and sexual harassment in this community. This purpose shall be accomplished by:

(A) Implementing community-wide educational programs to assist persons in becoming more aware of the high incidents of domestic violence, rape and sexual harassment;

✓ ~~(B) Utilizing the recommendations of the Mayor's Task Force on Domestic Violence dated November 2, 1990, and attached to Ordinance G-39-03 as a guide for further study;~~

~~(C)~~ (B) Promoting and strengthening the interactions among agencies which support victims dealing with the legal system;

~~(D)~~(C) Advocating appropriate legislative and judicial reforms which hold abusers accountable for their behavior; and

~~(E)~~(D) Organizing all segments of the community to work together to discover ways to eliminate domestic violence, rape and sexual harassment.
