7 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL**
8 **OF THE CITY OF FORT WAYNE, ALLEN COUNTY, INDIANA:**

9 **SECTION 1.** Chapter 94 entitled "Fire Prevention Code" of the Code
10 of Ordinances of the City of Fort Wayne, Indiana, is hereby amended to add
11 Section 94.50: FIRE WATCH as follows:

12 **FIRE WATCH**

13 **ADD NEW §94.50 FIRE WATCH**

14 Fort Wayne Fire Department personnel shall perform fire watch when it is
15 ordered by the Fire Chief and required by Indiana Fire Code. The entity
16 and/or business will be billed for fire watch services at the hourly rate of the
17 city employee(s) performing fire watch duties, including overtime rates in the
18 amount of one and one half of the hourly rate, if applicable.

19 **SECTION 2.** That this Ordinance shall be in full force and effect from
20 and after its passage and any and all necessary approval by the Mayor.
