3 **AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA**

4 **REPEALING**

5 **ALL OF SECTION 32.02 OF THE FORT WAYNE CODE OF ORDINANCES OF THE CITY OF FORT**

6 **WAYNE AND REPLACING IT WITH A NEW SECTION 32.02 OF SAID CODE**

8 **WHEREAS**, Indiana Code Section 36-4-6-3 allows that there be a redistricting or

9 redivision into six (6) Councilmanic Districts for the City of Fort Wayne so long as changes are in

10 compliance with I.C. 3-11-1.5.32 and other requirements.

11 **WHEREAS**, in response to the 2020 Decennial Federal Census, Common Council believe

12 it is necessary to redistrict and/or re-divide the six (6) Councilmanic Districts due to shifts in

13 population and/or annexations.

14 **NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT**

15 **WAYNE, INDIANA:**

16 **SECTION 1.** That Section 32.02 of the Fort Wayne Code of Ordinances is hereby repealed

17 in its entirety and is replaced with the following:

18 **§ 32.02 COUNCILMANIC DISTRICTS**

19 A. The City if hereby divided and the following Councilmanic Districts are hereby

**SECTION 2.** Subsequent to the passage of this section, the Allen County Election Board shall file with the City Clerk a legal description of the territory comprised of the above-listed precincts in each Councilmanic District, which legal description shall remain on file in the Office of the City Clerk. Additionally, the Allen County Election Board shall renumber, as necessary, all precincts located in each City Councilmanic District in consecutive order, and a list of the numbered precincts in each Councilmanic District shall likewise be filed with the City Clerk. The legal description of any territory annexed to the city included in each City Councilmanic District and any newly created numbered precincts included in said territory shall be placed on file with the Office of the City Clerk by the Allen County Election Board as amendments to the legal descriptions of said Councilmanic Districts and to the list of precincts included in said Councilman District on file in said Office.

**SECTION 3.** Attached hereto and marked "Exhibit A" and made a part of this Ordinance is a map showing the new boundaries of each Councilmanic District in the City of Fort Wayne.

**SECTION 4.** That this ordinance shall be in full force and effect from and after its passage and any and all necessary approval by the Mayor.
