

3 AN ORDINANCE AMENDING CHAPTER 53 OF THE
4 FORT WAYNE, INDIANA CODE OF ORDINANCES

5 WHEREAS, the City of Fort Wayne, Indiana, Department of Stormwater
6 Management ("DSM") plays a pivotal role in helping to protect the City's water sources
7 by managing the quantity and quality of stormwater runoff within the City's municipal
8 boundaries; and

9 WHEREAS, one of the ways in which the DSM exercises this role is by actively
10 engaging in development projects involving the disturbance of one (1) acre or more of
11 total land area; and

12 WHEREAS, for such projects, state law requires the owner of the property to
13 submit stormwater plans describing proposed efforts to mitigate stormwater pollution
14 and manage additional stormwater runoff generated as a result of the project; and

15 WHEREAS, the DSM is the local agency responsible for reviewing the property
16 owner's stormwater plans, helping to ensure that the plans meet all state and local
17 regulations and helping to ensure ongoing compliance with construction site
18 management and post-construction requirements through recurring inspections; and

19 WHEREAS, the DSM also has several regulated drains under its jurisdiction,
20 which form a part of the DSM's overall stormwater management system; and

21 WHEREAS, state law permits owners of properties impacted by a regulated
22 drain to petition the DSM requesting changes to the drain or to allow certain
23 encroachments and crossings in, over, through, and across the statutory right of way
24 associated with such drains; and

25 WHEREAS, the DSM dedicates a significant amount of resources to reviewing
26 stormwater plans, inspecting project sites to ensure compliance with the plans and post-
27 construction BMPs, reviewing requests for changes to regulated drains, and reviewing
28 requests for encroachments/crossings in, over, through, and across the statutory right of
29 way for such drains; and

30 WHEREAS, the State continues to increase its requirements for the DSM's
implementation of stormwater plan reviews, construction site management and water
quality monitoring and expects the DSM to continue to modify its practices and
ordinances to meet those requirements; and

WHEREAS, to ensure the DSM can continue the efforts described above without
increasing general stormwater fees for customers of the DSM, the Common Council of
the City of Fort Wayne, Indiana ("Common Council") believes it is appropriate to
establish a schedule of fees for stormwater plan review, inspections and certain
requests related to regulated drains under the DSM's control.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE
CITY OF FORT WAYNE, INDIANA:

1 **SECTION 1.** That Section 53.11 of the Fort Wayne Code of Ordinances be
2 deleted in its entirety and replaced with the following:

3 **§ 53.11 APPLICABILITY AND EXEMPTIONS.**

4 (A) It shall be required that a Notice of Intent (NOI) be submitted to the Indiana
5 Department of Environmental Management and to the DSM and that a Stormwater
6 Pollution Prevention Plan (SWPPP) be submitted and approved by the DSM for any
7 project located within the Fort Wayne Stormwater Management District that includes
8 clearing, grading, excavation, filling and other land disturbing activities resulting in the
9 following:

10 (1) The disturbance of one (1) acre or more of total land area as determined in
11 § 53.13.

12 (2) Disturbances of less than one acre of land that are part of a larger common plan
13 of development or sale if the larger common plan will ultimately disturb one or more
14 acres of land.

15 (B) The SWPPP must be approved by the DSM prior to the beginning of any land
16 disturbing activities on the site for which the plan is submitted. The SWPPP must comply
17 with the design criteria and technical standards and specifications approved by the
18 BSM.

19 (C) This Chapter does not apply to the following types of activities:

- 20 (1) Agricultural land disturbance activities.
21 (2) Forest harvesting activities.

22 (D) This section does not apply to the following activities, provided other applicable
23 permits contain provisions requiring immediate implementation of soil erosion control
24 measures:

- 25 (1) Landfills that have been issued a certification of closure under 329 IAC 10.
26 (2) Coal mining activities under IC 14-34.
27 (3) Municipal solid waste landfills that are accepting waste pursuant to a permit
28 issued by IDEM under 329 IAC 10 that contains equivalent stormwater requirements,
29 including the expansion of landfill boundaries and construction of new cells either within
30 or outside the original solid waste permit boundary.

 (4) Roadway projects initiated by the Indiana Department of Transportation.

 (E) Charges for review of SWPPP submittals will be assessed in accordance with
Section 53.63.

SECTION 2. That Section 53.30 of the Fort Wayne Code of Ordinances be
deleted in its entirety and replaced with the following:

§ 53.30 INSPECTION, MAINTENANCE AND REPORTING.

 (A) Upon the approval of the SWPPP and the issuance of all other required permits
and approvals by the DSM the following shall occur during the period of construction
activities:

 (1) The BSM, or its designee, shall have the authority to conduct inspections of the
site to ensure full compliance with the provisions of this Chapter, the design standards
and technical specifications by the BSM and the terms and conditions of the approved
SWPPP.

 (2) A self-monitoring program shall be implemented by the project site owner to
ensure the stormwater pollution prevention plan is working effectively. The program
must include the following:

 (a) A trained individual shall perform an inspection and prepare a written
evaluation of the project site:

1. By the end of the next business day following each 0.5 inch of rain; and
 2. At a minimum of one time per week.

- (b) The evaluation must:
1. Address the maintenance of existing stormwater quality measures to ensure they are functioning properly; and
 2. Identify additional measures necessary to remain in compliance with all applicable laws and ordinances.

- (c) Written evaluation reports must include:
1. The name of the individual performing the evaluation;
 2. The date of the evaluation;
 3. Problems identified at the project site; and
 4. Details of corrective actions recommended and completed.

(d) All evaluation reports for the project site must be made available to the inspecting authority within forty-eight (48) hours of a request.

(e) Sites that are issued a Notice of Violation (NOV) for non-compliance with an approved SWPPP will be charged for time spent on each re-inspection until the site is brought into compliance in accordance with the table set forth in Section 53.63.

(B) Upon completion of the construction activities the following shall occur perpetually in accordance with the SWPPP regardless of site usage and land ownership:

(1) All constructed stormwater quality facilities shall be maintained by the property owner, or per agreements on file with the DSM, and be in good condition and in accordance with the approved SWPPP operation and maintenance procedures and schedules and the BSM approved technical standards.

(2) The approved stormwater quality facilities shall not be subsequently altered, revised or replaced except in accordance with the approved SWPPP or in accordance with DSM approved amendments or revisions to the SWPPP.

(3) The BSM, or its designee, shall have the authority to conduct inspections of the site and the installed BMPs to ensure full compliance with the provisions of this Chapter, the design standards and technical specifications approved by the BSM and terms and conditions of the SWPPP. Fees for such inspections shall be charged in accordance with the table set forth in Section 53.63.

SECTION 3. That Section 53.63 titled "MISCELLANEOUS STORMWATER CHARGES" is added to the Fort Wayne Code of Ordinances as a NEW Section to read as follows:

§ 53.63 MISCELLANEOUS STORMWATER CHARGES.

(A) *SWPPP Submittal Review and Fees.* The following table contains the hourly fees to be charged for review of SWPPP/stormwater plan submittals and compliance inspections.

Permit/Fee Type	Extra Submittal Review – Rate Per Hour ¹	Extra SWPPP Inspection – Rate Per Hour ²
Single Residential Lot	\$140.00	\$80.00
Development (0-19.99 acres) ³	\$265.00	\$220.00
Development (20+ acres)	\$355.00	\$220.00

Time spent on plan reviews beyond the initial submittal and two (2) resubmittals will be charged at these hourly rates until the submittal is approved. For projects involving consultants, the time measurement is based on the senior consulting engineer's time spent on the review.

1 ² Sites that have been issued a Notice of Violation (NOV) will incur a re-inspection cost

9 (B) *Regulated Drain Fees.* Fees for review of petitions involving regulated drains will
10 be assessed in accordance with the following table:

Drain Reconstruction/Drain Vacation/Drain Abandonment	\$760.00

11 (C) *BMP Inspection Fees.* Fees for inspections of BMPs will be assessed in
12 accordance with the following table.

Permit/Fee Type	Annual BMP Inspection Fee ⁴	BMP Extra Inspection Hourly Rate (\$/Hour) ⁵
Stormwater BMP	\$520.00	\$290.00

13 ⁴ The inspection fee for a single private BMP if the required annual inspection is not
14 performed by the property owner and/or information from the property owner does not
15 meet City Utilities' requirements.

16 ⁵ Sites with BMP deficiencies identified in site inspections will incur a re-inspection cost
17 for time spent on each inspection until the site is brought into compliance. For projects
18 involving only City Utilities in the inspection, the cost per hour is measured based on the
19 City Utilities' staff time spent on the review. For projects involving consultants, the time
20 measurement is based on the senior consulting engineer's time spent on the review.

21 **SECTION 4.** That except for the foregoing amendments, the remaining
22 sections of Chapter 53 of the City of Fort Wayne, Indiana, Code of Ordinances shall
23 remain in full force and effect.

24 **SECTION 5.** That all ordinances or parts of ordinances in conflict herewith are
25 hereby repealed.

26 **SECTION 6.** That this Ordinance shall be in full force and effect from and after its
27 passage and any and all necessary approval by the Mayor.

(2) Forest harvesting activities.

(D) This section does not apply to the following activities, provided other applicable permits contain provisions requiring immediate implementation of soil erosion control measures:

(1) Landfills that have been issued a certification of closure under 329 IAC 10.

(2) Coal mining activities under IC 14-34.

(3) Municipal solid waste landfills that are accepting waste pursuant to a permit issued by IDEM under 329 IAC 10 that contains equivalent stormwater requirements, including the expansion of landfill boundaries and construction of new cells either within or outside the original solid waste permit boundary.
