4 **AN ORDINANCE TO AMEND CHAPTER 130.04 IN THE FORT WAYNE CODE OF**  
5 **ORDINANCES**

7 **WHEREAS**, on February 11, 2020, the Fort Wayne Common Council passed G-4-20  
8 adding Section 130.04 to Chapter 130 of the Fort Wayne Code; and

9  
10 **WHEREAS**, the purpose of Section 130.04 is to allow a process by which to identify  
11 Disorderly Houses, where illegal activity occurs in owner-occupied dwellings and adversely  
12 impacts the health, safety, welfare, and quality of life for residents of Fort Wayne; and

13  
14 **WHEREAS**, G-4-20 had a sunset provision 3 years from the date of passage included  
15 within the ordinance to allow a point for the effectiveness of the ordinance to be assessed; and

16  
17 **WHEREAS**, the data gathering by the FWPD and other impacted departments for an  
18 assessment of effectiveness is still in process; and,

19  
20 **WHEREAS**, it is the duty of Common Council to provide tools like the authority granted  
21 under this chapter to public safety agencies to ensure the continued safety of our neighborhoods.

23 **NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF**  
24 **THE CITY OF FORT WAYNE, INDIANA, AS FOLLOWS:**

26 **SECTION 1. In order to keep Section 130.04 of Chapter 130 of the Fort Wayne Code**  
27 **in force and effect**, subsection I of §130.04, of the Fort Wayne (the sunset provision) Code is  
28 repealed and Common Council ratifies all remaining provisions of Section 130.04 of the Fort  
29 Wayne Code

30  
31 **SECTION 2.** This Ordinance shall be in full force and effect from and after its passage  
32 and any and all necessary approval by the Mayor.
