5 AN ORDINANCE amending Section 10.17: Ordinances Which  
6 Amend or Supplement Code of the Fort Wayne Code of  
7 Ordinances

9 WHEREAS, Fort Wayne Code of Ordinances (Code) provides a process by which the Fort  
10 Wayne Common Council (Council), as the legislative body of the City of Fort Wayne, may amend  
11 existing chapters or sections of the Code or supplement with new chapters or sections; and

12  
13 WHEREAS, the City Administration and the Council agree that these amendments could be made  
14 more efficiently if amendments to subsections also were allowed;

15  
16 WHEREAS, the Council believes it is in the City’s best interest to amend Section 10.17 to allow  
17 for such amendments.



19 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY**  
20 **OF FORT WAYNE, INDIANA:**

22 **SECTION 1.** That Section 10.17 of the Fort Wayne Code of Ordinances: “Ordinances Which  
23 Amend or Supplement Code” is hereby deleted and replaced with the following:

25 (A) If the legislative body shall desire to amend any existing chapter, section, or subsection of  
26 this code, the chapter, section, or subsection shall, by amendment, be specifically deleted in  
27 its entirety and a new chapter, section, or subsection, containing the desired amendment,  
28 substituted in its place.

30 (B) Any ordinance which is proposed to add to the existing code a new chapter, section, or  
31 subsection shall indicate, with reference to the arrangement of this code, the proper number  
32 of such chapter, section, or subsection. In addition to such indication thereof as may appear in  
33 the text of the proposed ordinance, a caption or title shall be shown in concise form above the  
34 ordinance.

37 **SECTION 2.** That this Ordinance shall be in full force and effect from and after its passage and  
38 any and all necessary approval by the Mayor.
