10 **WHEREAS**, on June 24, 2014, the Fort Wayne Common Council voted to
11 eliminate Collective Bargaining for all non-public safety City workers; and

13 **WHEREAS**, the elimination of the employees Collective Bargaining rights has
14 long been a point of discussion for members of City Council.

16 **WHEREAS**, this change will provide the City Council and Mayor's Administration
17 the ability to implement a new system.

20 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE**
21 **CITY OF FORT WAYNE, INDIANA:**

23 **SECTION 1.** Repeal section § 40.02 of the Fort Wayne Municipal Code of Ordinances in
24 its entirety. Notwithstanding the foregoing, nothing in this ordinance is intended to nor does it
25 grant rights to the non-safety employees of the City of Fort Wayne, to collectively bargain with
26 the City.

28 **SECTION 2.** That this Ordinance shall be in full force and effect from and after its
29 passage and any and all approval by the Mayor.
