AN ORDINANCE amending Chapter 157 Section 506
of the City of Fort Wayne Municipal Code

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the current Section 157.506 (Definitions) are hereby amended as follows.

Amendment DEF1 - 157.506(B)

Definition of Arcade: To clarify that the definition of Arcade should state that betting or gambling facility is not included; added a statement to clarify the definition of Arcade: "This definition does not include betting or gambling facility or casino."

Amendment DEF2 - 157.506(B)

Betting or Gambling Facility is not defined; added a definition for Betting or Gambling Facility stating "a structure or facility in which games of chance are performed by a for-profit or non-profit organization, including off-track betting, where permanent tables are not present. This definition does not include casino."


Amendment DEF3 - 157.506(B)

Bingo Establishment is not defined; added a definition for Bingo Establishment stating "a structure or facility in which bingo operations are performed by a for-profit or non-profit organization."

Amendment DEF4 - 157.506(B)


Casino is not defined; added a definition for Casino stating "a structure or facility in which gaming operations are performed by a for-profit or non-profit organization, where permanent tables are present. This definition does not include betting or gambling facility."

SECTION 2. That this Ordinance, after its passage and approval by the Mayor, shall be in full force and effect starting on January 10, 2024.


