6 **CHAPTER 153 "PLANNING & DEVELOPMENT OF**

9 WHEREAS, Common Council of the City of Fort Wayne adopted a Comprehensive
10 Plan for the City of Fort Wayne (All-in-Allen), in accordance with the statutes of the State of
11 Indiana; and,

12 WHEREAS, on March 17, 2025, the Fort Wayne Plan Commission initiated the
13 amendment of the Comprehensive Plan to adopt the goals and policies of the East Central
14 Forward Plan; and,

15 WHEREAS, the Common Council desires to amend Section 153.07 to recognize the
16 amendment of the East Central Forward Plan to the Comprehensive Plan which will repeal
17 and replace the East Park Planning Alliance: A Neighborhood Plan for the East Central
18 Neighborhood (2005); and

19 WHEREAS, the City Plan Commission, in accordance with the Planning Statutes of
20 the State of Indiana held a public hearing on the Amendment to the Comprehensive Plan;
21 and,

22 WHEREAS, this ordinance is to establish an amendment to the Comprehensive
23 Plan to include the goals and policies of the East Central Forward Plan and the repeal of the
24 East Park Planning Alliance: A Neighborhood Plan for the East Central Neighborhood
25 (2005);

26 NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF
27 FORT WAYNE, INDIANA:

28 SECTION 1. Section 153.07 of Chapter 153 (Planning & Development) of the
29 City of Fort Wayne is amended by repealing the following subsection:

30 *(E) East Park Planning Alliance: A Neighborhood Plan for the East Central*
Neighborhood (2005). The Comprehensive Plan is amended by adding the goals and
policies of the "East Park Planning Alliance: A Neighborhood Plan for the East Central
Neighborhood" as set forth in that plan.

SECTION 2. Section 153.07 of Chapter 153 (Planning & Development) of the City of Fort Wayne is amended by including the following subsection and relettering the other subsections accordingly:

(O) *East Central Forward Plan (2025)*. The Comprehensive Plan is amended by adding the goals and policies of the "East Central Forward Plan" as set forth in that Plan.

SECTION 3. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

Synopsis of Ordinance: A proposal to amend the All in Allen Comprehensive Plan by

Location: The study area extends (approximately) from the 400 block of East
Jefferson Boulevard to the 1700 block of Maumee Avenue, and
(approximately) from the 1700 block of South Anthony Boulevard to
the 2000 block of South Anthony Boulevard. The (approximate) area
is located south of the Maumee River, north of the CSX
Transportation Inc. Railway, east of Lafayette Street, and west of
South Anthony Boulevard.

Effect of Passage: Adopting the goals and strategies of the East Central Forward
Neighborhood Plan will help fulfill a request of the East Central

In alignment with the *All in Allen Comprehensive Plan* – specifically, Housing & Neighborhoods, Goal 1: Support and Strengthen Complete Neighborhoods, and Policy 1.6: Encourage Neighborhood Activation and Planning – the City of Fort Wayne, in partnership with the East Central Planning Committee, has developed the **East Central Forward Neighborhood Plan**.

This planning effort began in the fall of 2023, following an official request from the East Central Neighborhood Association to update the existing neighborhood plan. Since then, city staff and a dedicated volunteer steering committee have diligently worked to gather extensive community input from nearly 420 residents, business owners, and stakeholders in the neighborhood.

Building upon the foundation of the 2005 *East Park Plan*, **East Central Forward** includes updated Demographic data, along with new goals and policies, and reflects the community's current priorities. The plan focuses on key areas, including neighborhood safety, walkability, housing improvements, access to recreation and wellness, and celebrating the neighborhood's rich history and heritage.

On **March 17, 2025**, the Fort Wayne Plan Commission formally initiated the adoption process for the East Central Forward plan. As part of the next steps, the plan is set to be introduced to Common Council on **April 22, 2025**, followed by a public hearing hosted by the Plan Commission on **May 12, 2025**.

Staff members from the City of Fort Wayne's Department of Neighborhoods will prepare the Staff Report and provide all necessary documentation for the public hearing process.

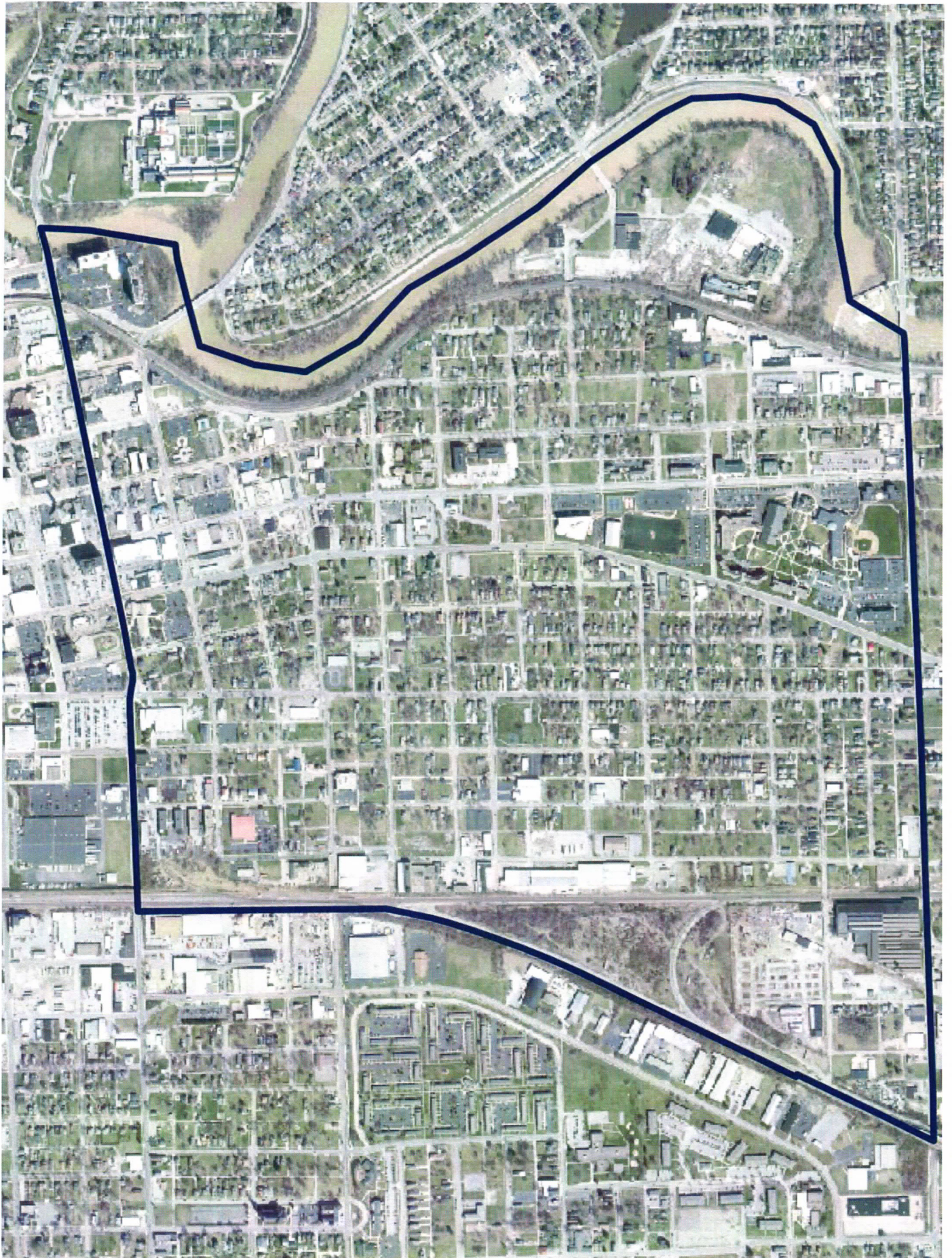

WHAT IS THE PLANNING PROCESS?

The **East Central Forward** planning process began in the Fall of 2023 due to an initial effort of the East Central Neighborhood to pursue a neighborhood plan.

This partnership began with a steering committee made up of leaders and residents of East Central. The planning area is called East Central Forward to honor the current efforts to move the neighborhood forward, and to acknowledge past efforts that have historically left little impact. This neighborhood represents a deep, rich culture that has emphasized the wants and needs to move the area in a positive and supportive way.

East Central Forward is founded on stakeholder and resident contributions. From 2023–2025 over four hundred community members were engaged including youth and seniors, property owners and renters, elected officials, workers, and business owners. Over 20 events and workshops have been held in-person and online, including working group meetings, neighborhood walks, open houses, and neighborhood meetings at various locations including Hanna Homestead Park, Foellinger Foundation, and MKM Architecture. Additional engagement included print and online surveys in English and Spanish. Overall about 420 neighborhood residents were engaged in the planning process to elicit a complete picture of the community's priorities and desires.



The following principles serve as the foundation of East Central Forward, guiding all strategies, actions, and recommendations within the plan. Rooted in the community's values and priorities, these principles reflect a shared vision for a stronger, more connected, and resilient neighborhood. They respond to both present-day challenges and long-term opportunities, ensuring that East Central remains a place where residents feel safe, supported, and proud to call home.

Planning Principles:

Safe Community

We believe that all residents deserve to feel safe in their neighborhoods. East Central Forward prioritizes strategies that strengthen public safety, encourage community involvement, and create inviting public spaces. By fostering a greater sense of trust, connection, and visibility, we aim to enhance safety and peace of mind throughout East Central.

History and Heritage

East Central's past is a source of strength and identity. This plan supports efforts to celebrate the neighborhood's cultural heritage, honor those who have shaped it, and preserve historic places and stories. By elevating community memory, we build pride and support connections to East Central for future generations.

Walkability

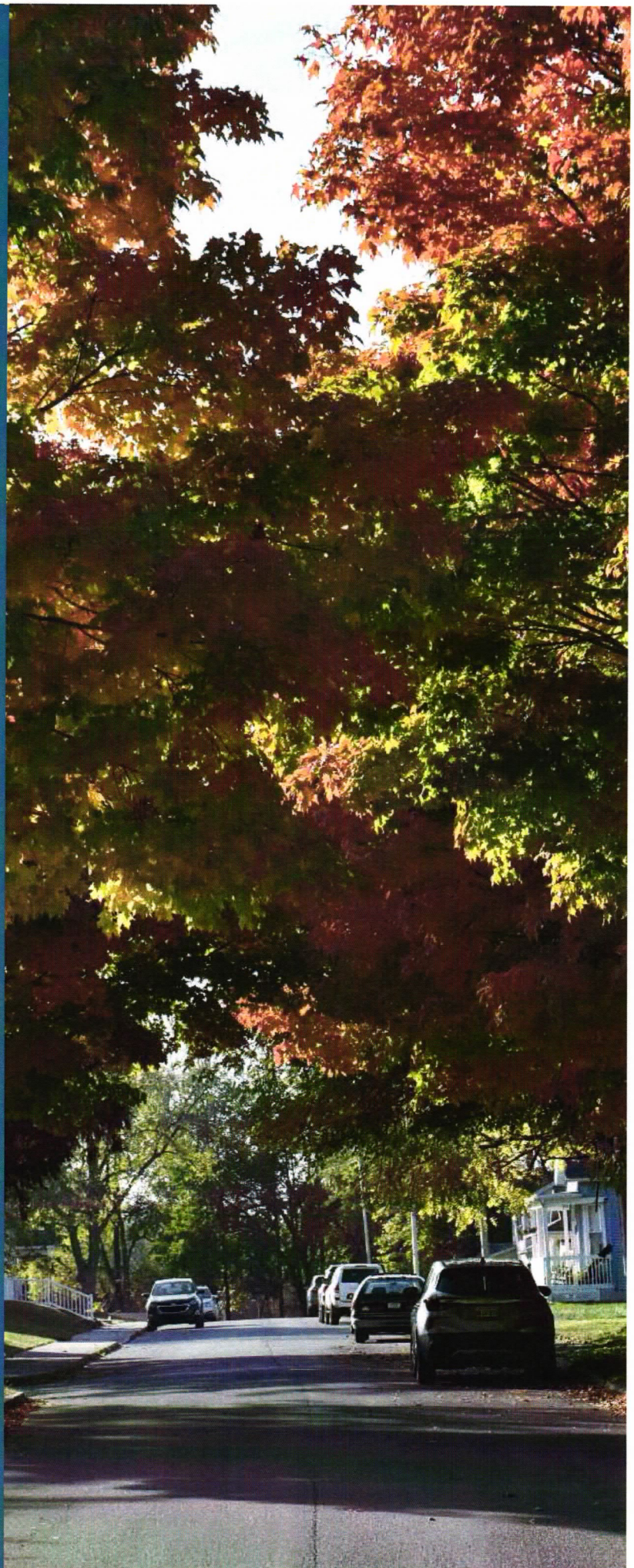
A walkable neighborhood is a livable neighborhood. East Central Forward emphasizes the importance of safe, connected, and accessible pedestrian infrastructure. We prioritize sidewalk improvements near schools, parks, and activity centers to promote healthier lifestyles and improve mobility for people of all ages and abilities.

Improved Housing

Stable, quality housing is the heart of a strong neighborhood. East Central Forward promotes housing that is safe, affordable, and well-maintained. Supporting reinvestment in existing homes, responsible infill development, and policies that help residents remain in their homes and build long-term stability.

Recreation and Wellness

Access to recreation and wellness resources is essential to community well-being. East Central Forward advocates for the enhancement of parks, trails, and community spaces as hubs for physical activity, connection, and health services. Ensuring that every resident has access to safe, vibrant places to play, gather, and thrive.



GOAL ONE: East Central residents actively contribute to and take pride in a safe, clean, and beautiful neighborhood

1.1 Empower residents to enhance the cleanliness and appearance of East Central through community-led cleanup initiatives.

1.2 Improve safety and security in East Central by implementing Crime Prevention Through Environmental Design (CPTED) Strategies.

GOAL TWO: East Central's history and heritage are a source of community pride and are actively celebrated

2.1 Engage the East Central community in identifying, preserving, and celebrating its history and historic resources.

2.2 Tell the story of East Central's history and heritage through compelling public art and signage that enhances the neighborhood's identity and sense of place.

2.3 Establish a strong visual identity for East Central by enhancing neighborhood gateways that clearly define its boundaries and celebrate its unique character.

GOAL THREE: East Central offers residents a range of safe, high-quality, and affordable housing options that meet diverse needs and preferences

3.1 Enhance East Central's housing stock through maintenance, improvement, and preservation efforts.

3.2 Increase housing availability and diversity in East Central through strategic infill development.

3.3 Expand homeownership opportunities in East Central.

GOAL FOUR: East Central residents have access to safe, reliable, and connected infrastructure

4.1 Encourage connectivity and expansion of the city Trail Network in the East Central Neighborhood.

4.2 Support safe access to public transit within the East Central Neighborhood.

4.3 Improve pedestrian safety and accessibility throughout the neighborhood.

4.4 Improve physical linkages between East Central and Downtown Fort Wayne to enhance connectivity for residents and businesses.

GOAL FIVE: East Central residents enjoy equitable access to and actively utilize high-quality parks, public spaces, and recreational facilities that foster community and enhance quality of life

5.1 Assess the needs of East Central's diverse community and develop a plan to adapt public facilities and parks to address identified needs.

5.2 Enhance community engagement and resident well-being in East Central through targeted programming.

GOAL SIX: Development in East Central reflects the community's vision for its future.

6.1 Encourage the alignment and modification of zoning district designations that support desired development and reflect the community's vision for East Central.

GOAL SEVEN: East Central are well connected to social events, community partners, and neighbors

7.1 Increase community awareness and participation in East Central activities and events.

7.2 Foster small business growth and development in East Central by connecting entrepreneurs and small business owners with the City of Fort Wayne SEED program.

7.3 Strengthen the partnership between East Central and Indiana Tech to enhance community development.

GOAL EIGHT: East Central fosters a healthy and sustainable community for residents to live, work, and play

8.1 Improve physical and mental health outcomes for East Central residents.

8.2 Work with local agencies to develop Physical and mental health support services in the East Central

8.3 Enhance access to resources and support for unsheltered residents in East Central through collaborative partnerships.

8.4 Enhance environmental sustainability and resilience in East Central.
