

3 AN ORDINANCE AMENDING CHAPTER 52:  
4 WATER AND WATERCOURSES  
5 CITY OF FORT WAYNE, CODE OF ORDINANCES

6 WHEREAS, the Common Council of the City of Fort Wayne, Indiana last approved a water rate  
7 adjustment in General Ordinance G-11-19 on May 28, 2019, which was subsequently amended  
8 by General Ordinance G-7-22 on April 26, 2022; and

9 WHEREAS, the Fort Wayne Water Utility has developed a Capital Improvement Plan (“CIP”)  
10 that will allow the Water Utility to continue to provide its customers with safe, reliable, and  
11 affordable drinking water through sustainable levels of capital spending on treatment facilities'  
12 parts and equipment, field maintenance equipment, water main replacement and other structures  
13 and facilities positioned throughout the service territory; and

14 WHEREAS, Baker Tilly was hired by Fort Wayne City Utilities to analyze the Water Utility's  
15 pro forma revenues, proposed CIP, and other projected cash flows in order to arrive at water rates  
16 that will generate sufficient funds to meet the fiscal needs of the Water Utility including:

- 17 (A) Payment of all of the legal and other necessary expenses incident to the  
18 operation of the utility;
- 19 (B) Provision of a sinking fund, a debt service reserve, adequate money for  
20 working capital and making extensions and replacements to the extent not  
21 provided for through depreciation;
- 22 (C) Provision of money for the payment of any taxes that may be assessed against  
23 the utility; and
- 24 (D) Meeting the financial obligations of the Utility's CIP.

25 WHEREAS, Baker Tilly has concluded that the existing rates and charges for the use of and  
26 services rendered by the Fort Wayne Water Utility do not produce sufficient revenue to satisfy  
27 the requirements of I.C. 8-1.5-3-8, including but not limited to those costs related to the Utility's  
28 CIP and therefore recommends that the existing rates and charges should be adjusted in phases,  
29 each implemented one year after the other, as further described below.

30 WHEREAS, Baker Tilly also analyzed the Water Utility's non-recurring fees and concluded that  
the non-recurring fees should be adjusted in various ways as described below; and

WHEREAS, the Board of Public Works of the City of Fort Wayne, Indiana has recommended  
that the Common Council act in accordance with I.C. 8-1.5-3-8 to find and elect that the rates and  
charges for water service to be paid by users of the system should be sufficient to carry out the

obligations of the Water Utility as outlined above, to provide a fair and reasonable return on the Utility plant of the City and to compensate the City for taxes that would be due to the City on the Utility property were it privately owned and to adjust the Water Utility's non-recurring fees in accordance with the conclusions of Baker Tilly;

**NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

**SECTION 1.** That the Common Council of the City of Fort Wayne, Indiana now finds and elects that the rates and charges for water service to be paid by users of the system should be sufficient to carry out the obligations of the Water Utility as outlined above, to provide a fair and reasonable return on the Utility plant of the City and to compensate the City for taxes that would be due to the City on the Utility property were it privately owned;

**SECTION 2.** The following sections of Chapter 52 of the Fort Wayne Code of Ordinances are hereby amended to adjust the rates and charges assessed to Fort Wayne Water Utility customers as recommended by Baker Tilly in three (3) phases, with the current 2025 rates remaining in effect upon passage of this Ordinance, the Phase I rates taking effect upon approval of said rates and charges by the Indiana Utility Regulatory Commission, the Phase II rates taking effect 12 months after the Phase I rates, and the Phase III rates taking effect 12 months after the Phase II rates.

**SECTION 3.** Section 52.15 of the Fort Wayne Code of Ordinances is hereby deleted in its entirety and replaced with the following:

**Sec. 52.15**     **Water Usage Schedule - Inside City**

There shall be and hereby are established for the use of and the service rendered by the waterworks system of the City the following rates and charges based on the use of water supplied by the City Waterworks System:
