

**A DECLARATORY RESOLUTION designating an
"Economic Revitalization Area" under I.C. 6-1.1-
12.1 for property commonly known as 8415 North
Clinton Park Drive, Fort Wayne, Indiana 46825
(AccuTemp Products, Inc.)**

WHEREAS, Petitioner has duly filed its petition dated May 10, 2011 to have the following described property designated and declared an "Economic Revitalization Area" under Sections 153.13-153.24 of the Municipal Code of the City of Fort Wayne, Indiana, and I.C. 6-1.1-12.1, to wit:

Attached hereto as "Exhibit A" as if a part herein;

and

WHEREAS, said project will retain 39 full-time and one part-time, permanent jobs for a total current annual payroll of \$2,699,632, with the average current, annual job salary being \$67,491; and

WHEREAS, the total estimated project cost is \$36,080; and

WHEREAS, it appears the said petition should be processed to final determination in accordance with the provisions of said Division 6.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That, subject to the requirements of Section 6, below, the property hereinabove described is hereby designated and declared an "Economic Revitalization Area" under I.C. 6-1.1-12.1. Said designation shall begin upon the effective date of the Confirming Resolution referred to in Section 6 of this Resolution and shall terminate on December 31, 2011, unless otherwise automatically extended in five year increments per I.C. 6-1.1-12.1-9.

SECTION 2. That, upon adoption of the Resolution:

- (a) Said Resolution shall be filed with the Allen County Assessor;
- (b) Said Resolution shall be referred to the Committee on Finance requesting a recommendation from said committee concerning the advisability of designating the above area an "Economic Revitalization Area";
- (c) Common Council shall publish notice in accordance with I.C. 6-1.1-12.1-2.5 and I.C. 5-3-1 of the adoption and substance of this resolution and setting this designation as an "Economic Revitalization Area" for public hearing;

1 **SECTION 3.** That, said designation of the hereinabove described property as an
2 "Economic Revitalization Area" shall apply to a deduction of the assessed value of personal
3 property for new information technology equipment.

4 **SECTION 4.** That, the estimate of the number of individuals that will be employed
5 or whose employment will be retained and the estimate of the annual salaries of those
6 individuals and the estimate of the value of new information technology equipment, all
7 contained in Petitioner's Statement of Benefits, are reasonable and are benefits that can be
8 reasonably expected to result from the proposed described installation of new information
9 technology equipment.

10 **SECTION 5.** That, the current year approximate tax rates for taxing units within
11 the City would be:

12 (a) If the proposed new information technology equipment is not installed, the
13 approximate current year tax rates for this site would be \$3.0527/\$100.

14 (b) If the proposed new information technology equipment is installed and no
15 deduction is granted, the approximate current year tax rate for the site would be
16 \$3.0527/\$100 (the change would be negligible).

17 (c) If the proposed new information technology equipment is installed and a
18 deduction percentage of eighty percent (80%) is assumed, the approximate
19 current year tax rate for the site would be \$3.0527/\$100 (the change would be
20 negligible).

21 **SECTION 6.** That, this Resolution shall be subject to being confirmed, modified
22 and confirmed, or rescinded after public hearing and receipt by Common Council of the
23 above described recommendations and resolution, if applicable.

24 **SECTION 7.** That, pursuant to I.C. 6-1.1-12.1, it is hereby determined that the
25 deduction from the assessed value of the new information technology equipment shall be for
26 a period of ten years.

27 **SECTION 8.** That, the benefits described in the Petitioner's Statement of Benefits
28 can be reasonably expected to result from the project and are sufficient to justify the
29 applicable deductions.


30 **SECTION 9.** That, the taxpayer is non-delinquent on any and all property tax due
to jurisdictions within Allen County, Indiana.

SECTION 10. That, pursuant to I.C. 6-1.1-12.1-12 et al, any property owner that
has received a deduction under section 3 or 4.5 of said chapter may be required to repay the
deduction amount as determined by the county auditor in accordance with section 12 of said
chapter if the property owner ceases operations at the facility for which the deduction was
granted and if the Common Council finds that the property owner obtained the deduction by


