

A DECLARATORY RESOLUTION designating an "Economic Revitalization Area" under I.C. 6-1.1-12.1 for property commonly known as 5211 Industrial Road, Fort Wayne, Indiana 46825 (Pyromation, Inc.)

WHEREAS, Petitioner has duly filed its petition dated May 20, 2011 to have the following described property designated and declared an "Economic Revitalization Area" under Sections 153.13-153.24 of the Municipal Code of the City of Fort Wayne, Indiana, and I.C. 6-1.1-12.1, to wit:

Attached hereto as "Exhibit A" as if a part herein;

and

WHEREAS, said project will create 39 full-time, permanent jobs for a total new, annual payroll of \$1,118,000, with the average new annual job salary being \$28,667 and retain 172 full-time and two part-time, permanent jobs for a total current annual payroll of \$8,504,868, with the average current, annual job salary being \$48,879; and

WHEREAS, the total estimated project cost is \$3,325,000; and

WHEREAS, it appears the said petition should be processed to final determination in accordance with the provisions of said Division 6.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That, subject to the requirements of Section 6, below, the property hereinabove described is hereby designated and declared an "Economic Revitalization Area" under I.C. 6-1.1-12.1. Said designation shall begin upon the effective date of the Confirming Resolution referred to in Section 6 of this Resolution and shall terminate on December 31, 2011, unless otherwise automatically extended in five year increments per I.C. 6-1.1-12.1-9.

SECTION 2. That, upon adoption of the Resolution:

- (a) Said Resolution shall be filed with the Allen County Assessor;
- (b) Said Resolution shall be referred to the Committee on Finance requesting a recommendation from said committee concerning the advisability of designating the above area an "Economic Revitalization Area";
- (c) Common Council shall publish notice in accordance with I.C. 6-1.1-12.1-2.5 and I.C. 5-3-1 of the adoption and substance of this resolution and setting this designation as an "Economic Revitalization Area" for public hearing;

1 **SECTION 3.** That, said designation of the hereinabove described property as an
2 "Economic Revitalization Area" shall apply to both a deduction of the assessed value of real
3 estate and personal property for new manufacturing and information technology equipment.

4 **SECTION 4.** That, the estimate of the number of individuals that will be employed
5 or whose employment will be retained and the estimate of the annual salaries of those
6 individuals and the estimate of the value of redevelopment or rehabilitation and the estimate
7 of the value of new manufacturing and information technology equipment, all contained in
8 Petitioner's Statement of Benefits, are reasonable and are benefits that can be reasonably
9 expected to result from the proposed described redevelopment or rehabilitation and from the
10 installation of new manufacturing and information technology equipment.

11 **SECTION 5.** That, the current year approximate tax rates for taxing units within
12 the City would be:

- 13 (a) If the proposed development does not occur, the approximate current year tax
14 rates for this site would be \$3.0384/\$100.
- 15 (b) If the proposed development does occur and no deduction is granted, the
16 approximate current year tax rate for the site would be \$3.0384/\$100 (the
17 change would be negligible).
- 18 (c) If the proposed development occurs and a deduction percentage of fifty percent
19 (50%) is assumed, the approximate current year tax rate for the site would be
20 \$3.0384/\$100 (the change would be negligible).
- 21 (d) If the proposed new manufacturing equipment is not installed, the approximate
22 current year tax rates for this site would be \$3.0384/\$100.
- 23 (e) If the proposed new manufacturing equipment is installed and no deduction is
24 granted, the approximate current year tax rate for the site would be
25 \$3.0384/\$100 (the change would be negligible).
- 26 (f) If the proposed new manufacturing equipment is installed and a deduction
27 percentage of eighty percent (80%) is assumed, the approximate current year
28 tax rate for the site would be \$3.0384/\$100 (the change would be negligible).
- 29 (g) If the proposed new information technology equipment is not installed, the
30 approximate current year tax rates for this site would be \$3.0384/\$100.
- (h) If the proposed new information technology equipment is installed and no
deduction is granted, the approximate current year tax rate for the site would be
\$3.0384/\$100 (the change would be negligible).
- (i) If the proposed new information technology equipment is installed and a
deduction percentage of eighty percent (80%) is assumed, the approximate

1 current year tax rate for the site would be \$3.0384/\$100 (the change would be
2 negligible).

3 **SECTION 6.** That, this Resolution shall be subject to being confirmed, modified
4 and confirmed, or rescinded after public hearing and receipt by Common Council of the
5 above described recommendations and resolution, if applicable.


6 **SECTION 7.** That, pursuant to I.C. 6-1.1-12.1, it is hereby determined that the
7 deduction from the assessed value of the real property shall be for a period of ten years, and
8 the deduction from the assessed value of the new manufacturing and information technology
9 equipment shall be for a period of ten years.

10 **SECTION 8.** That, the benefits described in the Petitioner's Statement of Benefits
11 can be reasonably expected to result from the project and are sufficient to justify the
12 applicable deductions.


13 **SECTION 9.** That, the taxpayer is non-delinquent on any and all property tax due
14 to jurisdictions within Allen County, Indiana.

15 **SECTION 10.** That, pursuant to I.C. 6-1.1-12.1-12 et al, any property owner that
16 has received a deduction under section 3 or 4.5 of this chapter may be required to repay the
17 deduction amount as determined by the county auditor in accordance with section 12 of said
18 chapter if the property owner ceases operations at the facility for which the deduction was
19 granted and if the Common Council finds that the property owner obtained the deduction by
20 intentionally providing false information concerning the property owner's plans to continue
21 operation at the facility.

22 **SECTION 11.** That, this Resolution shall be in full force and effect from and after
23 its passage and any and all necessary approval by the Mayor.
