4 **A RESOLUTION INITIATING THE**  
5 **AMENDMENT OF FORT WAYNE'S**  
6 **COMPREHENSIVE PLAN, PLAN-IT-ALLEN,**  
7 **TO ADOPT THE FRONT DOOR FORT**  
8 **WAYNE (GATEWAY) PLAN.**

9 **WHEREAS**, the City of Fort Wayne, through its Common Council,  
10 desires the development of Transportation and Economic Development  
11 plans to implement the goals, policies, and recommendations of its  
12 Comprehensive Plan, Plan-It-Allen, in order to: Encourage and plan for  
13 context-sensitive design to enhance local character and ensure that new  
14 development, redevelopment and roadway improvements are integrated;  
15 design understandable and attractive gateway enhancements that promotes  
16 continued investment; provide the community with fully accessible, multi-  
17 modal transportation options and infrastructure; Develop methods and  
18 procedures for maintaining current and future gateway area improvements;  
19 promote and market Fort Wayne to support tourism and attract investment  
20 into the community;

22 **WHEREAS**, I.C. 36-7-4-511 allows the legislative body to initiate an  
23 amendment of the Comprehensive Plan by adopting a resolution to amend it,  
24 and direct the Plan Commission to prepare the amendment and submit it in  
25 the same manner as any other amendment to the comprehensive plan.


