4 **A RESOLUTION INITIATING THE AMENDMENT OF FORT**
5 **WAYNE'S COMPREHENSIVE PLAN, PLAN-IT-ALLEN, TO**

7 **WHEREAS**, the City of Fort Wayne, through its Common Council,
8 desires the development of Transportation plans to implement the goals,
9 policies, and recommendations of its Comprehensive Plan, Plan-It-Allen, in
10 order to: Encourage and plan for fully accessible and safe alternative
11 transportation options and infrastructure; determine the need for safe
12 pedestrian and public transit improvements; educate the public about
13 benefits of active and public transportation; and encourage safe accessibility
14 and connectivity to primary destinations for citizens of all ages and physical
15 abilities;

17 **WHEREAS**, I.C. 36-7-4-511 allows the legislative body to initiate an
18 amendment of the Comprehensive Plan by adopting a resolution to amend it,
19 and direct the Plan Commission to prepare the amendment and submit it in
20 the same manner as any other amendment to the comprehensive plan.

22 **NOW, THEREFORE, BE IT RESOLVED BY THE COMMON**
23 **COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

24 **SECTION 1.** To initiate the amending of the City of Fort Wayne's
25 Comprehensive Plan, Plan-It-Allen, to include the Bus Fort Wayne Plan and
26 for the Plan Commission to prepare and submit the amendment within 60
27 days after the formal written request by the legislative body.

TITLE OF RESOLUTION: A Resolution initiating an amendment of the City of Fort Wayne Comprehensive Plan, Plan-It-Allen, to adopt the Bus Fort Wayne Plan.

DEPARTMENT REQUESTING RESOLUTION: City of Fort Wayne Community Development Division.

SYNOPSIS OF RESOLUTION: This resolution initiates (per I.C. 36-7-4-511) an amendment to the City's Comprehensive Plan, Plan-It-Allen, to incorporate the goals and policies of the Bus Fort Wayne Plan.

EFFECT OF PASSAGE: The initiation of the required process for amending the City's Comprehensive Plan. After Resolution passage, the Plan Commission will then prepare the amendment, conduct a public hearing, and upon approval, certify the amendment to the Comprehensive Plan to Common Council for final consideration.

EFFECT OF NON-PASSAGE: Prevents the initiation of an amendment to the City's Comprehensive Plan to incorporate the goals and policies of the Bus Fort Wayne Plan, thus lessening the plan's ability to impact decision making and resource allocation, with respect to providing efficient, coordinated and adequate public transit services and facilities throughout the City of Fort Wayne and Allen County. Without planned and coordinated public transit facilities and service provision, improvements to public transportation options will continue to be inadequate throughout the community.
