

2 A RESOLUTION APPROVING THE DISTRIBUTION OF

5 WHEREAS, the City of Fort Wayne has created the City of Fort Wayne Community
6 Legacy Fund to invest in projects that will have a collective impact that leads to transformational
7 change within the community, and;

8 WHEREAS, the City of Fort Wayne through the Legacy process has received
9 unprecedented public input from across the community and has worked with citizens, business
10 leaders and elected officials to develop implementation priorities, and;

11 WHEREAS, the City of Fort Wayne seeks to advance transformational projects
12 for our community with a focus on economic development, downtown and riverfront development,
13 and youth development/prep sports, and;

14 WHEREAS, each Legacy project provides our community with an opportunity to
15 make our City stronger and better positioned for growth, and;

16 WHEREAS, by working together, we will leave a lasting Legacy for future
17 generations.

18 NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF
19 THE CITY OF FORT WAYNE, INDIANA:

20 SECTION 1. The City of Fort Wayne Common Council hereby authorizes
21 the Board of Trustees of the City of Fort Wayne Community Legacy Fund to distribute funds to
22 the following projects:
