A RESOLUTION APPROVING THE DISTRIBUTION OF FUNDS FROM THE CITY OF FORT WAYNE COMMUNITY LEGACY FUND FOR THE INVESTMENT IN NEIGHBORHOOD INFRASTRUCTURE.

WHEREAS, the City of Fort Wayne has created the City of Fort Wayne Community Legacy Fund to invest in projects that will have a collective impact that leads to transformational change within the community, and;

WHEREAS, strong infrastructure builds up neighborhoods and dilapidating infrastructure weakens neighborhoods, and;

WHEREAS, strong neighborhoods are the foundation of a great City, and;

WHEREAS, the City of Fort Wayne and Common Council committed \$1,000,000 per year for years 2013-2017 through the process of the Fiscal Policy, and;

WHEREAS, the 2013 commitment was approved through final passage of Resolution No. R-28-13 on March 6, 2013.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. The City of Fort Wayne Common Council hereby authorizes the Board of Trustees of the City of Fort Wayne Community Legacy Fund to distribute funds to the following projects:


Neighborhood Infrastructure Improvements

Funds in the amount of \$4,000,000 or \$1,000,000/year for years 2014 through 2017 for needed neighborhood street repairs and replacements, helping build a stronger community, preserving the attractiveness of Fort Wayne as a wonderful place to live, and provide needed infrastructure.
