

3 A CONFIRMING RESOLUTION designating an "Economic  
4 Revitalization Area" and approving a waiver of non-compliance under  
5 I.C. 6-1.1-12.1 for property commonly known as 310 Racquet Drive,  
6 Fort Wayne, Indiana 46825 (Racquet Drive Holdings, LLC/Transformations  
7 by Wieland, Inc.)

8 WHEREAS, Common Council has previously designated and declared by Declaratory Resolution  
9 the following described property as an "Economic Revitalization Area" under Sections 153.13-153.24 of  
10 the Municipal Code of the City of Fort Wayne, Indiana, and I.C. 6-1.1-12.1, to wit:

11 Attached hereto as "Exhibit A" as if a part herein; and

12 WHEREAS, said project will result in the occupation of an eligible vacant building under I.C. 6-1.1-  
13 12.1-4.8; and

14 WHEREAS, said project will create 10 full-time, permanent jobs for a total new, annual payroll of  
15 \$327,000, with the average new annual job salary being \$32,700 and retain 48 full-time and 5 part-time,  
16 permanent jobs for a total current annual payroll of \$1,748,000, with the average current, annual job salary  
17 being \$32,981; and

18 WHEREAS, the total estimated project cost is \$986,758; and

19 WHEREAS, representatives of Racquet Drive Holdings, LLC/Transformations by Wieland, Inc.  
20 informed Common Council that the real and personal property improvements for which they are  
21 requesting designation of an Economic Revitalization Area under I.C. 6-1.1-12.1 are complete; and

22 WHEREAS, Racquet Drive Holdings, LLC/Transformations by Wieland, Inc. has submitted a  
23 written request for a waiver of non-compliance under I.C. 6-1.1-12.1-11.3; and

24 WHEREAS, I.C. 6-1.1-12.1-11.3 permits non-compliance events such as the untimely filing of an  
25 application, statement of benefits, or another document required to be filed under I.C. 6-1.1-12.1; and

26 WHEREAS, the Common Council acknowledges that Racquet Drive Holdings,  
27 LLC/Transformations by Wieland, Inc. has requested a waiver of non-compliance which the Common  
28 Council has the power and authority to approve under I.C. 6-1.1-12.1-11.3; and

29 WHEREAS, Common Council finds that Racquet Drive Holdings, LLC/Transformations by  
30 Wieland, Inc. did not comply with I.C. 6-1.1-12.1 by:

(a) failure to provide the completed statement of benefits forms to the Common Council before  
the public hearing,

(b) failure to submit the completed statement of benefits form to the Common Council before  
initiation of redevelopment or rehabilitation,

(c) failure to submit the completed statement of benefits form to the Common Council before  
installation of new manufacturing, research and development, logistical distribution, and information  
technology equipment; and

1           **WHEREAS**, notice of the adoption and substance of said Resolution has been published in  
2 accordance with I.C. 6-1.1-12.1-2.5, I.C. 6-1.1-12.1-11.3(c) and I.C. 5-3-1 and a public hearing has been  
3 conducted on said Resolution and waiver.

4           **WHEREAS**, representatives of Racquet Drive Holdings, LLC/Transformations by Wieland, Inc.  
5 were in attendance and presented testimony on why a waiver should be granted; and

6           **WHEREAS**, a recommendation has been received from the Committee on Finance concerning  
7 said Resolution; and

8           **NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT**  
9 **WAYNE, INDIANA:**

10           **SECTION 1.** That, Common Council hereby adopts a waiver of non-compliance with I.C. 6-1.1-  
11 12.1-11.3 regarding:

12           (a) failure to provide the completed statement of benefits forms to the common council before the  
13 public hearing,

14           (b) failure to submit the completed statement of benefits form to the common council before  
15 initiation of redevelopment or rehabilitation, and

16           (c) failure to submit the completed statement of benefits form to the common council before  
17 installation of new manufacturing, research and development, logistical distribution, and information  
18 technology equipment;

19 for which Racquet Drive Holdings, LLC/Transformations by Wieland, Inc. desires to claim an Economic  
20 Revitalization Area deduction. Such waiver shall be in effect for real and personal property improvements  
21 during the period of February 1, 2015 through the date of this resolution.

22           **SECTION 2.** That, the Resolution previously designating the above described property as an  
23 "Economic Revitalization Area" is confirmed in all respects.

24           **SECTION 3.** That, the hereinabove described property is hereby declared an "Economic  
25 Revitalization Area" pursuant to I.C. 6-1.1-12.1, said designation to begin on the effective date of this  
26 Resolution and shall terminate on December 31, 2016, unless otherwise automatically extended in five  
27 year increments per I.C. 6-1.1-12.1-9.

28           **SECTION 4.** That, said designation of the hereinabove described property as an "Economic  
29 Revitalization Area" shall apply to both a deduction of the assessed value of occupation of an eligible  
30 vacant building, real estate, and personal property for new manufacturing, research and development,  
logistical distribution, and information technology equipment.

**SECTION 5.** That, the estimate of the number of individuals that will be employed or whose  
employment will be retained and the estimate of the annual salaries of those individuals and the estimate  
of the value of the occupation of the eligible vacant building and the value of the redevelopment or  
rehabilitation of the eligible vacant building and the estimate of the value of the new manufacturing,  
research and development, logistical distribution, and information technology equipment, all contained in  
Petitioner's Statement of Benefits are reasonable and are benefits that can be reasonably expected to

1 result from the proposed described installation of the new manufacturing, research and development,  
2 logistical distribution, and information technology equipment.

3 **SECTION 6.** The current year approximate tax rates for taxing units within the City would be:

- 4 (a) If the proposed development does not occur, the approximate current year tax rates for this  
5 site would be \$3.1973/\$100.
- 6 (b) If the proposed development does occur and no deduction is granted, the approximate  
7 current year tax rate for the site would be \$3.1973/\$100 (the change would be negligible).
- 8 (c) If the proposed development occurs, and a deduction percentage of fifty percent (50%) is  
9 assumed, the approximate current year tax rate for the site would be \$3.1973/\$100 (the  
10 change would be negligible).
- 11 (d) If the proposed new manufacturing, research and development, logistical distribution, and  
12 information technology equipment is not installed, the approximate current year tax rates for  
13 this site would be \$3.1973/\$100.
- 14 (e) If the proposed new manufacturing, research and development, logistical distribution, and  
15 information technology equipment is installed and no deduction is granted, the approximate  
16 current year tax rate for the site would be \$3.1973/\$100 (the change would be negligible).
- 17 (f) If the proposed new manufacturing, research and development, logistical distribution, and  
18 information technology equipment is installed and a deduction percentage of eighty percent  
19 (80%) is assumed, the approximate current year tax rate for the site would be \$3.1973/\$100  
20 (the change would be negligible).
- 21 (g) If the proposed occupation of the eligible vacant building does not occur, the approximate  
22 current year tax rates for this site would be \$3.1973/\$100.
- 23 (h) If the proposed occupation of the eligible vacant building occurs and no deduction is granted,  
24 the approximate current tax rate for the site would be \$3.1973/\$100 (the change would be  
25 negligible).
- 26 (i) If the proposed occupation of the eligible vacant building occurs, and a deduction percentage  
27 of fifty percent (50%) is assumed, the approximate current year tax rate for this would be  
28 \$3.1973/\$100 (the change would be negligible).

29 **SECTION 7.** That, pursuant to I.C. 6-1.1-12.1, it is hereby determined that the deduction from  
30 the assessed value of the eligible vacant building shall be for a period of one year, the deduction from the  
assessed value of the real property shall be for a period of five years, and that the deduction from the  
assessed value of the new manufacturing, research and development, logistical distribution, and  
information technology equipment shall be for a period of seven years.

**SECTION 8.** The deduction schedule from the assessed value of the real property pursuant to  
I.C. 6-1.1-12.1-17 shall look like this:

**SECTION 9.** The deduction schedule from the assessed value of new manufacturing, research and development, logistical distribution, and information technology equipment pursuant to I.C. 6-1.1-12.1-17 shall look like this:

**SECTION 10.** The deduction schedule from the assessed value of the vacant building pursuant to I.C. 6-1.1-12.1-17 shall look like this:

**SECTION 11.** That, the benefits described in the Petitioner's Statement of Benefits can be reasonably expected to result from the project and are sufficient to justify the applicable deductions.

**SECTION 12.** For new manufacturing, research and development, logistical distribution, and information technology equipment, a deduction application must contain a performance report showing the extent to which there has been compliance with the Statement of Benefits form approved by the Fort Wayne Common Council at the time of filing. This report must be submitted to the Allen County Auditor's Office, and the City of Fort Wayne's Community Development Division and must be included with the deduction application. For subsequent years, the performance report must be updated and submitted along with the deduction application at the time of filing.

**SECTION 13.** For real property, a deduction application must contain a performance report showing the extent to which there has been compliance with the Statement of Benefits form approved by

1 the Fort Wayne Common Council at the time of filing. This report must be submitted to the Allen County  
2 Auditor's Office and the City of Fort Wayne's Community Development Division and must be included in  
3 the deduction application. For subsequent years, the performance report must be updated each year in  
4 which the deduction is applicable at the same time the property owner is required to file a personal  
5 property tax return in the taxing district in which the property for which the deduction was granted is  
6 located. If the taxpayer does not file a personal property tax return in the taxing district in which the  
7 property is located, the information must be provided by May 15.

8 **SECTION 14.** For the eligible vacant building, a deduction application must contain a  
9 performance report showing the extent to which there has been compliance with the Statement of Benefits  
10 form approved by the Fort Wayne Common Council at the time of filing. This report must be submitted to  
11 the Allen County Auditor's Office and the City of Fort Wayne's Community Development Division and must  
12 be included in the deduction application. For subsequent years, the performance report must be updated  
13 each year in which the deduction is applicable at the same time the property owner is required to file a  
14 personal property tax return in the taxing district in which the property for which the deduction was granted  
15 is located. If the taxpayer does not file a personal property tax return in the taxing district in which the  
16 property is located, the information must be provided by May 15.

17 **SECTION 15.** The performance report must contain the following information:


- 18 A. The cost and description of real property improvements and/or new manufacturing, research  
19 and development, logistical distribution, and information technology equipment acquired.
- 20 B. The number of employees hired through the end of the preceding calendar year as a result of  
21 the deduction.
- 22 C. The total salaries of the employees hired through the end of the preceding calendar year as a  
23 result of the deduction.
- 24 D. The total number of employees employed at the facility receiving the deduction.
- 25 E. The total assessed value of the real and/or personal property deductions.
- 26 F. The tax savings resulting from the real and/or personal property being abated.

27 **SECTION 16.** That, the taxpayer is non-delinquent on any and all property tax due to  
28 jurisdictions within Allen County, Indiana.


29 **SECTION 17.** That, pursuant to I.C. 6-1.1-12.1-12 et al, any property owner that has received a  
30 deduction under section 3 or 4.5 of this chapter may be required to repay the deduction amount as  
determined by the county auditor in accordance with section 12 of said chapter if the property owner  
ceases operations at the facility for which the deduction was granted and if the Common Council finds that  
the property owner obtained the deduction by intentionally providing false information concerning the  
property owner's plans to continue operation at the facility.
