21 WHEREAS, the Fort Wayne Redevelopment Commission and the
22 Fort Wayne City Plan Commission took the forgoing actions as set forth in
23 the preceding two paragraphs herein are in accordance with the provisions
24 of the Redevelopment of Blighted Areas Act of 1981 (P.L. 309 and 310 of
25 the Acts of 1981 of the General Assembly of the State of Indiana, as



RESOLUTION 2016-36



DECLARATORY RESOLUTION OF THE FORT WAYNE REDEVELOPMENT COMMISSION, GOVERNING BODY OF THE CITY OF FORT WAYNE DEPARTMENT OF REDEVELOPMENT, AMENDING AND RESCINDING THE WASHINGTON CENTER COLDWATER ROAD ECONOMIC DEVELOPMENT AREA PLAN

WHEREAS, on 3 March 1989, the Fort Wayne Redevelopment Commission adopted Confirmatory Resolution 89-13 that confirmed and approved the establishment of the Washington Center Coldwater Road Economic Development Area (EDA); and

WHEREAS, on 12 May 2008, the Fort Wayne Redevelopment Commission adopted resolution 2008-43 which approved Amendment I to the Washington Center Coldwater Road Economic Development Area by adding a segment of Washington Center Road (from Dartmouth Drive to Coldwater Road) to the EDA; and

WHEREAS, following a period of study and coordination with the Allen County Auditor and other City staff, Commission staff recommend that the Commission amend the aforesaid Washington Center Coldwater Road Economic Development Area and its accompanying Tax Allocation Area by rescinding Confirmatory Resolutions 89-3 and 2008-43 in their entirety, and;

WHEREAS, the provisions of I.C. 36-7-14-39 were engaged, from time to time, during the course of the existence of the EDA. Current collection of tax increment has ceased and approximately \$91,333.00 remains in the Washington Center Coldwater Road Tax Allocation Fund. Said funds are programmed to be used for a City Utilities infrastructure project currently under design which will serve the EDA. Specific approval for this project and the expenditure of the aforesaid funds will be brought before the Commission when design and programming are complete.


WHEREAS, in accordance with state statute, the Redevelopment Commission will follow the process delineated for amending a redevelopment area (EDA/URA) which includes a determination from the Fort Wayne City Plan Commission that the amendment is in conformity to the plan of development for the Unit, approval by the Common Council of the City of Fort Wayne, publication of a legal public hearing and a final determination (confirmatory resolution) by the Commission thereafter; and


WHEREAS, following the adoption of a confirmatory resolution amending and thereby rescinding Confirmatory Resolutions 89-13 and 2008-43, no powers of the Commission granted by I.C. 36-7-14 shall be applicable to the aforesaid EDA; and

NOW, THEREFORE, BE IT RESOLVED by the Fort Wayne Redevelopment Commission, Governing Body of the City of Fort Wayne, Department of Redevelopment, that:

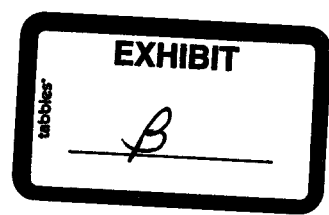

MEMORANDUM

RE: Rescission of Economic Development Areas and Urban Renewal Area (EDA/URA)

DT: July 15, 2016

On May 9, 2016, the Fort Wayne Redevelopment Commission adopted Resolutions 2016-36, 2016-37 and 2016-38, copies attached, which propose to rescind the Washington Center Coldwater Road EDA, Moeller Meyer Road EDA and Baker Street URA. These entities ("TIF Districts") were created in 1989, 2002 and 1992.

The provisions of the Washington Center Coldwater Road Economic Development Area plan have been fulfilled and the Commission has determined that the powers enabled by statute are no longer needed. The provisions of the Moeller Meyer Road Economic Development Plan were never engaged or implemented due to a key element of the project never materializing. The provisions of the Baker Street URA were never engaged due to alternate sources of funding being used to stabilize the station when it was under City ownership.

Pursuant to I.C. 36-7-14-16 and 36-7-14-41, the Plan Commission determined that these resolutions and action contemplated are in in general conformity to the plan of development for the City of Fort Wayne (Plan It Allen) at its business meeting on June 13, 2016 per the attached resolution. In order for these actions to move forward, each must be approved by the Common Council of the City of Fort Wayne. As such, the purpose of this memo is to request that consideration of these resolutions (attached hereto) be made by City Council. If approved, these resolutions will be presented to the Redevelopment Commission for final consideration following a legal public hearing.
