

A RESOLUTION approving a Waiver of Noncompliance for Late-Filed Compliance with Statement of Benefits Real Estate Improvements (CF-1/Real Property) and determining Substantial Compliance/Non-Compliance for 9100 Airport Drive, Fort Wayne, IN 46809 (Global Seal Logistics, Inc. for Pro Seal & Plastics, LLC)

WHEREAS, Pursuant to Sections 153.13-153.24 of the Municipal Code of the City of Fort Wayne, Indiana and I.C. 6-1.1-12.1, Common Council has previously designated and declared by Declaratory Resolution and Confirming Resolution property at 9100 Airport Drive (Global Seal Logistics, Inc. for Pro Seal & Plastics, LLC) to be an economic revitalization area; and

WHEREAS, the Statement of Benefits (SB-1) and economic revitalization area designation application submitted by Global Seal Logistics, Inc. for Pro Seal & Plastics, LLC stated that four full-time jobs would be created by December 31, 2010.

WHEREAS, each year for the duration of a tax abatement, the owner/applicant is required by the Fort Wayne Code of Ordinances and State law to submit a Compliance with Statement of Benefits (CF-1/Real Property) so Common Council can determine whether the owner/applicant is in substantial compliance with its SB-1; and

WHEREAS, Common Council has defined substantial compliance under Section 153.21 of the Municipal Code of the City of Ft. Wayne as:

1. Meeting 75% or more of the numbers of full-time and/or part-time jobs stated to be created and/or retained as delineated in the original SB-1 approved by Common Council; and/or
2. Meeting 75% or more of the total payroll stated to be created or retained as delineated in the original Statement of Benefits Form SB-1 approved by Common Council; and

WHEREAS, for Global Seal Logistics, Inc. for Pro Seal & Plastics, LLC, meeting 75% of four full time jobs stated to be created on the original SB-1 means creating three jobs; and

WHEREAS, due to an oversight, Global Seal Logistics, Inc. for Pro Seal & Plastics, LLC did not timely file its CF-1/Real Property; and

WHEREAS, this oversight was an unusual occurrence for Global Seal Logistics, Inc. for Pro Seal & Plastics, LLC, which has made diligent efforts in good faith to make all required Indiana tax abatement filings on a timely basis; and

1 **WHEREAS**, Common Council made a determination on June 28, 2016, that Global
2 Seal Logistics, Inc. for Pro Seal & Plastics, LLC was not in substantial compliance by failing
3 to comply with I.C. 6-1.1-12.1 et seq. And Section 153.21(A) of the Fort Wayne Code of
4 Ordinances for failing to file their CF-1/Real Property; and

5 **WHEREAS**, Common Council directed the Community Development Division to mail
6 written notice to Global Seal Logistics, Inc. for Pro Seal & Plastics, LLC explaining the
7 reasons for Council's determination and a date, time, place of a hearing to be conducted by
8 Council for the purpose of further considering Global Seal Logistics, Inc. for Pro Seal &
9 Plastics, LLC's CF-1/Real Property; and

10 **WHEREAS**, Global Seal Logistics, Inc. for Pro Seal & Plastics, LLC has submitted its
11 CF-1/Real Property Form.

12 **WHEREAS**, A Waiver of Non-Compliance has been also been requested by Global
13 Seal Logistics, Inc. for Pro Seal & Plastics, LLC; and

14 **WHEREAS**, the Common Council acknowledges that Global Seal Logistics, Inc. for
15 Pro Seal & Plastics, LLC has requested a Waiver of Non-Compliance which the Common
16 Council has the power and authority to approve, under I.C. 6-1.1-12.1-9.5 and I.C. 6-1.1-
17 12.1-11.3; and

18 **WHEREAS**, the Common Council may, in its discretion, permit Global Seal Logistics,
19 Inc. for Pro Seal & Plastics, LLC to receive the tax abatement benefits to which it would have
20 been entitled had no non compliance event occurred, so long as the waiver of non
21 compliance and the granting of those benefits does not prejudice the City of Fort Wayne; and

22 **WHEREAS**, the Common Council has concluded that granting of the ERA deduction
23 for 2016 payable 2017 tax year would not create a strain on the City of Fort Wayne's fiscal
24 budget; and

25 **WHEREAS**, I.C. 6-1.1-12.1-9.5 and I.C. 6-1.1-12.1-11.3 permit tax abatement non
26 compliance events such as the untimely filing of a Compliance with Statement of Benefits
27 form to be waived; and

28 **WHEREAS**, the noncompliance event has been corrected and a public hearing of
29 the Common Council on the waiver was held on May 9, 2017.

30 **NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF
FORT WAYNE, INDIANA:**

SECTION 1a. That Common Council hereby waives all clerical and technical errors
and nonconformities that are waivable under State and local law, including failure to timely
file a Compliance with Statement of Benefits Real Estate Improvements and further finds,
based on the information furnished at the hearing on the Waiver of Non-Compliance, that

Global Seal Logistics, Inc. for Pro Seal & Plastics, LLC is in substantial compliance with its Statement of Benefits Form. Global Seal Logistics, Inc. for Pro Seal & Plastics, LLC shall receive its real property abatement for 2016 payable 2017 under Confirming Resolution R-52-07. A copy of this Resolution shall be furnished to the Auditor to apply the abatement for 2016 payable 2017.

SECTION 1b. That Common Council hereby waives all clerical and technical errors and nonconformities that are waivable under State and local law, including failure to timely file a Compliance with Statement of Benefits Real Estate Improvements, but finds, based on the information furnished at the hearing on the Waiver of Non-Compliance, that Global Seal Logistics, Inc. for Pro Seal & Plastics, LLC is not in substantial compliance with its Statement of Benefits Form. The abatement is therefore terminated.


