
8 WHEREAS, pursuant to the provisions of the Redevelopment of Blighted Areas Act of

10 amended and supplemented, on April 9, 2018, the Fort Wayne Redevelopment Commission  
11 adopted Declaratory Resolution 2018-17, attached hereto as Exhibit A, for the purpose of  
12 repealing the West Main Street Renewal Project ("URA"); and

13 WHEREAS, on April 16, 2018, the Fort Wayne Plan Commission considered said  
14 Declaratory Resolution 2018-17 and adopted a Resolution, attached hereto as Exhibit B,  
15 whereby said Plan Commission determined that repealing the URA conformed to the plan for  
16 development of the City of Fort Wayne;

17 **NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE**  
18 **CITY OF FORT WAYNE, INDIANA, THAT:**

19 Section 1. The approvals of the Fort Wayne Redevelopment Commission and Fort  
20 Wayne Plan Commission described herein are hereby approved, ratified and confirmed.

21 Section 2. This Resolution shall be in full force and effect from and after its passage  
22 and approval by the Fort Wayne Common Council and by the Mayor of the City of Fort

**RESOLUTION 2018-17  
FORT WAYNE REDEVELOPMENT COMMISSION**

**DECLARATORY RESOLUTION REPEALING THE  
WEST MAIN STREET RENEWAL PROJECT**

WHEREAS, on November 18, 1974, the Fort Wayne Redevelopment Commission ("Commission") adopted Declaratory Resolution 74-81 to establish the West Main Street Renewal Project in the area bounded by Maiden Ln. and Main, Ewing and Berry Sts. ("Renewal Project"); and

WHEREAS, on April 14, 1975 the Commission adopted Confirmatory Resolution 75-10, confirming establishment of the Renewal Project; and

WHEREAS, the Commission subsequently adopted Declaratory Resolutions 78-13 and 80-95, and Confirmatory Resolutions 75-83, 78-31 and 81-04, approving Amendments 1, 2 and 3 to the Renewal Project, which amendments changed certain goals of the Renewal Project and changed the boundaries thereof to the boundaries depicted in the attached Exhibit A; and

WHEREAS, the purposes for which the Renewal Project was established have been completed or have been incorporated within the boundaries and plans of current economic development areas or urban renewal areas, there are no remaining funds, obligated or unobligated, in any account related to the Renewal Project, and there are no pending, incomplete or outstanding obligations of the Commission or the City of Fort Wayne with respect to the Renewal Project; and

WHEREAS, the Commission has determined that the Renewal Project should be repealed to insure that the goals of the Renewal Project do not conflict with the goals of current economic development areas, urban renewal areas and/or other existing or proposed plans within the boundaries of the Renewal Project;

NOW, THEREFORE, BE IT RESOLVED by the Fort Wayne Redevelopment Commission that:

1. The foregoing recitals are true and are incorporated herein and made a part hereof.
2. Declaratory Resolutions 74-81, 78-13 and 80-95, and Confirmatory Resolutions 75-10, 75-83, 78-31 and 81-04, which resolutions collectively established and amended the West Main Street Renewal Project, are hereby rescinded, and the West Main Street Renewal Project is hereby repealed.
3. Following adoption of this Resolution, the Executive Director shall deliver a copy of this Resolution to the City's Plan Commission for its review and determination as to whether repealing the West Main Street Renewal Project conforms to the plan of development for the City, and shall request that the Plan Commission issue its written order approving the Resolution.
4. Following receipt of the Plan Commission's written approving order, the Executive Director shall deliver the Plan Commission's approving order together with this Resolution to the City's Common Council, and shall request that the Council issue its written order approving the Resolution.
5. Following receipt of the Common Council's written approving order, the Executive Director shall publish notice of the adoption and substance of this Resolution together with notice of a public

WHEREAS, after having been duly considered, the Plan Commission determined that the Declaratory Resolution conforms to the plan of development for the City of Fort Wayne;

NOW, THEREFORE, BE IT RESOLVED by the City of Fort Wayne Plan Commission that:

1. Redevelopment Commission Declaratory Resolution 2018-17 conforms to the plan of development for the City of Fort Wayne, and is hereby approved.
2. The Secretary of the Plan Commission is authorized to deliver to the Redevelopment Commission and to the City of Fort Wayne Common Council a copy of this fully executed Resolution, which shall constitute the approving order of the Plan Commission.


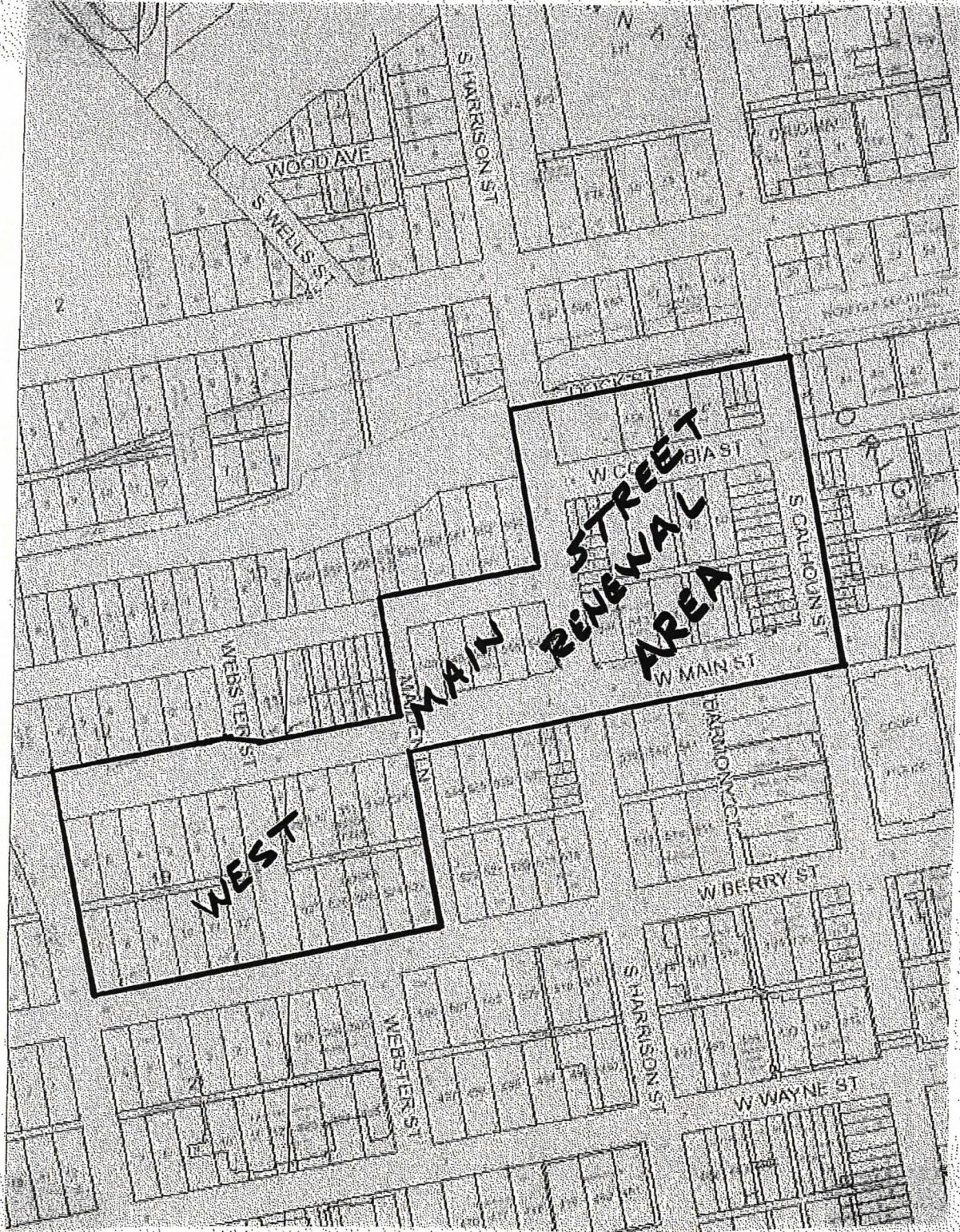

**TITLE OF RESOLUTION.** A Resolution confirming the approving order of the Fort Wayne Plan Commission, and Fort Wayne Redevelopment Commission Resolution 2018-17, repealing the West Main Street Renewal Project

**DEPARTMENT REQUESTING RESOLUTION.** Redevelopment Commission.

**SYNOPSIS OF RESOLUTION.** This repeals the West Main Street Renewal Project ("URA"). The Redevelopment Commission must publish notice and conduct a public hearing prior to taking final action to repeal the URA.

**EFFECT OF PASSAGE.** The West Main Street Renewal Project encompasses approximately 14 acres of land bounded generally by Ewing and Calhoun Sts., and by Berry and the railroad north of Columbia St. The URA was created in 1975 and amended three times by 1981. The URA is not a TIF district. It was used to establish the Senior Citizens' Center on Main St., promoted development of parking, retail and restaurants, and provided controls for historic preservation and restoration of existing structures where possible. Many of the proposals in the URA have been incorporated in the current master plan for the City, as well as in recent Economic Development, Urban Renewal and TIF Areas that overlap the URA. The URA is no longer required and should be repealed to insure that it is not in conflict with current programs.

**EFFECT OF NON-PASSAGE.** The plans for redevelopment of the Columbia St. corridor, and other development and redevelopment plans may be in conflict with the requirements of the URA.

**MONEY INVOLVED (DIRECT COSTS, EXPENDITURES, SAVINGS).** The URA does not generate revenue, and nothing is currently proposed to be done pursuant to the URA that would require funding.

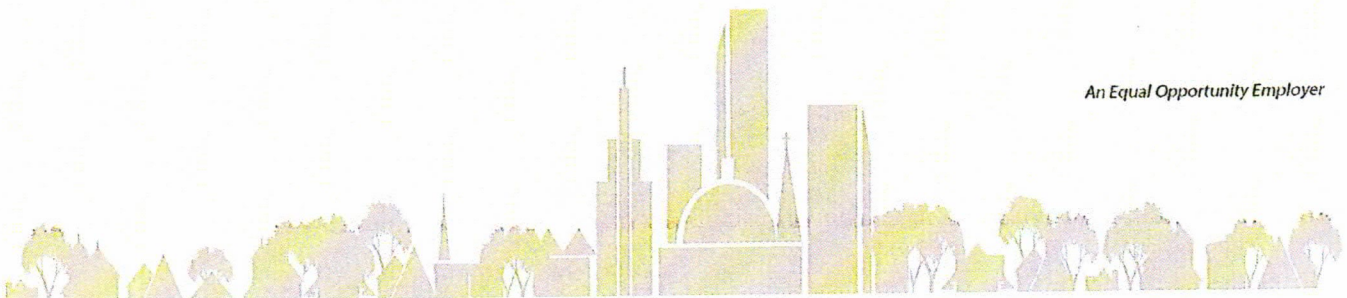
Pursuant to IC 36-7-14-16, please find enclosed herewith:
