6 WHEREAS, the City of Fort Wayne ("City") provides solid waste and recycling
7 collection and disposal services to its residents;


8 WHEREAS, the City contracts with private companies for the collection and
9 disposal of solid waste and recycling;

10 WHEREAS, Indiana Code 36-9-30 sets forth the requirements for local
11 governments to contract with private companies for the collection or disposal of solid
12 waste and requires such contracts to be awarded to the lowest responsible and responsive
13 bidder;

14 WHEREAS, the City believes it could better serve its residents if it could use the
15 Requests for Proposal ("RFP") bid process in its procurement of solid waste and
16 recycling collection and disposal services;


17 **NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL**

19 **SECTION 1.** That the Common Council formally requests that the state
20 legislators who represent Fort Wayne residents introduce and support legislation to
21 authorize local governments to enter into contracts for the collection and disposal of solid
22 waste and recycling through a RFP process instead of a lowest bid process.
