3 A RESOLUTION APPROVING THE FORT WAYNE
4 AMERICAN RESCUE PLAN ACT (ARPA) PAYMENT
5 OF ELIGIBLE SOLID WASTE DEPARTMENT
6 EXPENSES

7 **Whereas**, the U.S. Congress enacted the American Rescue Plan Act of
8 2021("ARPA") in March 2021; and,

9 **Whereas**, ARPA provides emergency funding to state and local
10 governments to support their recovery from the COVID-19 pandemic; and

11 **Whereas**, the City of Fort Wayne, Indiana has been allocated
12 \$50,815,327.00 from the Coronavirus State and Local Fiscal Recovery Funds
13 (under "ARPA"); and

14 **Whereas**, the Common Council of the City of Fort Wayne adopted Special
15 Ordinance on S-58-21 on May 11, 2021, which established the purpose, permitted
16 uses and minimum percentages per category of the ARPA fund; and

17 **Whereas**, the Common Council of the City of Fort Wayne adopted
18 Resolution R-22-03-22 on April 12, 2022 approving the City of Fort Wayne
19 Recovery Plan, State & Local Fiscal Recovery Funds; and

20 **Whereas**, the City of Fort Wayne must obligate its ARPA funds by the end
21 of 2024 and ultimately spend the funds by the end of 2026; and


22 **Whereas**, the City of Fort Wayne desires the Common Council to allocate a
23 portion of ARPA funds to pay eligible Solid Waste Department expenses.


1 million dollars of the ARPA funds to pay eligible Solid Waste Department expenses.
