NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:


SECTION 1. The acquisition of two (2) parcels of real estate by the City of Fort Wayne through its Board of Public Works, located at **6100**

- 2920 (beh) Pinewood Dr – Price: \$200.00


