WHEREAS, the City of Fort Wayne, through its Board of Public Works – Resolution #110-3-21-23-1, desires to acquire properties located at **6600-6800 BLOCKS OF FAIRFIELD AVE, 2500-2600 BLOCKS OF STRATHMORE ST, 2730 BEADELL ST, AND 2501 MORRIS ST, WAYNE TOWNSHIP, FORT WAYNE, INDIANA**, specifically described in the Resolution, Exhibit "A," attached hereto and made a part hereof; and

WHEREAS, the Resolution for the properties located on at **6600-6800 BLOCKS OF FAIRFIELD AVE, 2500-2600 BLOCKS OF STRATHMORE ST, 2730 BEADELL ST, AND 2501 MORRIS ST, WAYNE TOWNSHIP, FORT WAYNE, INDIANA**, is submitted to the Common Council for approval; and

WHEREAS, the purchase of these properties is for Public Works Flood Mitigation; and
