4 **A RESOLUTION Considering a Waiver of Non-Compliance**
5 **for Late-Filed Compliance with Statement of Benefits (Form**
6 **CF-1/Real Property) and Determination of Substantial**
7 **Compliance or Non-Compliance with Statement of Benefits**
8 **Approved under R-13-15 for 9403 Avionics Drive, Fort**
9 **Wayne, Indiana 46809 (TWE Nonwovens US, Inc.)**

10 **WHEREAS**, Common Council has previously designated and declared by Declaratory
11 Resolution and Confirming Resolution property at 9403 Avionics Drive for TWE Nonwovens US,
12 Inc. (Confirming Resolution R-13-15) under Sections 153.13-153.24 of the Municipal Code of the
13 City of Fort Wayne, Indiana, and I.C. 6-1.1-12.1; and

14 **WHEREAS**, The original Statement of Benefits and economic revitalization area
15 designation application submitted by TWE Nonwovens US, Inc. and approved under Confirming
16 Resolution R-13-15 was for \$1,700,000 in real property improvements and \$5,800,000 in personal
17 property improvements; and

18 **WHEREAS**, TWE Nonwovens US, Inc.'s 2023 Compliance with Statement of Benefits
19 (Form CF-1/Personal Property) was filed in a timely manner on, or prior to, May 15, 2023 with the
20 City of Fort Wayne and Allen County Assessor's Office; and

21 **WHEREAS**, TWE Nonwovens US, Inc.'s 2023 Compliance with Statement of Benefits
22 (Form CF-1/Real Property) was not filed in a timely manner on, or prior to, May 15, 2023 with the
23 City of Fort Wayne and Allen County Auditor's Office; and

24 **WHEREAS**, the City has given TWE Nonwovens US, Inc. notice to file their Compliance
25 with Statement of Benefits (Form CF-1/Real Property) and to submit an application for a waiver of
26 non-compliance for a late filed Compliance with Statement of Benefits (Form CF-1/Real
27 Property); and

28 **WHEREAS**, TWE Nonwovens US, Inc. has filed their Compliance with Statement of
29 Benefits (Form CF-1/Real Property) with the City of Fort Wayne and Allen County Auditor and
30 submitted an application for a waiver of non-compliance for failure to file their Compliance with
Statement of Benefits (Form CF-1/Real Property) in a timely manner; and

WHEREAS, the Common Council acknowledges that TWE Nonwovens US, Inc. has
requested a waiver of non-compliance which the Common Council has the power and authority
to approve, under I.C. 6-1.1-12.1-9.5); and

WHEREAS, TWE Nonwovens US, Inc. has fulfilled its pledge complete the project and
construct an approximately 30,000 square foot addition to its existing facility and purchase and
install new personal property manufacturing equipment; and

WHEREAS, Based on the CF-1 statement of benefits recently submitted, TWE
Nonwovens US, Inc. has established that they have substantially complied with its approved
statement of benefits; and

1 **WHEREAS**, I.C. 6-1.1-12.1-9.5 permits tax abatement noncompliance events such as
2 the untimely filed Compliance with Statement of Benefits (Form CF-1/Real Property) paperwork
3 to be waived; and

4 **WHEREAS**, if Common Council approves the waiver of non-compliance for the late filed
5 Compliance with Statement of Benefits (Form CF-1/Real Property) then Common Council will
6 also determine substantial compliance or non-compliance with statement of benefits; and

7 **WHEREAS**, a public hearing of the Common Council has been held on the waiver.

8 **NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT
9 WAYNE, INDIANA:**

10 **[OPTION 1]**

11 ~~**SECTION 1.** That, TWE Nonwovens US, Inc.'s request for a waiver of clerical and technical
12 errors and nonconformities with its Compliance with Statement of Benefits (Form CF-1/Real
13 Property) requirements is hereby denied and as such the phase in granted under Confirming
14 Resolution R-13-15 for real and personal property is terminated.~~

15 ~~**SECTION 2.** That this Resolution shall be in full force and effect from and after its passage and
16 any and all necessary approved by the Mayor.~~

17 **[OPTION 2]**

18 **SECTION 1.** That all clerical and technical errors and nonconformities of TWE Nonwovens US,
19 Inc.'s Compliance with Statement of Benefits (Form CF-1/Real Property) requirements that are
20 waivable under State and local law, including without limitation those errors and nonconformities
21 described in I.C. 6-1.1-12.1-9.5 are hereby waived.

22 **SECTION 2. [OPTION A]** That Common Council finds that the CF-1 forms filed by TWE
23 Nonwovens US, Inc. with an approved Economic Revitalization Area for 2023 are in substantial
24 compliance pursuant to I.C. 6-1.1-12.1 and Section 153.21 of the Municipal Code of the City of
25 Fort Wayne by virtue of retaining 75% of the 82 full-time jobs, or 61 full-time jobs, that were
26 stated to be retained and retaining 75% of the \$2,548,845 in retained annual payroll, or
27 \$1,911,633, as well as 75% of the 22 additional full-time jobs, or 16 additional full-time jobs, that
28 were stated to be created and creating 75% of the \$620,149, or \$465,111, in created annual
29 payroll. Therefore, the continuation of TWE Nonwovens US, Inc.'s abatement is hereby
30 approved. The Allen County Auditor shall be supplied with a copy of this Resolution, upon
passage, and is instructed to apply the tax phase-in.




