

**A RESOLUTION terminating a designation for “Economic Revitalization Area” and real property tax phase-in approved under Resolution R-32-10 for property commonly known as 5503 Distribution Drive, Fort Wayne, Indiana 46825 (Trelleborg Sealing Solutions, Inc.)**

**WHEREAS**, Common Council has previously designated and declared by Declaratory Resolution and Confirming Resolution property at 5503 Distribution Drive for Trelleborg Sealing Solutions, Inc. (Confirming Resolution number R-32-10) under Sections 153.13-153.24 of the Municipal Code of the City of Fort Wayne, Indiana, and I.C. 6-1.1-12.1; and

**WHEREAS**, the original Statement of Benefits and economic revitalization area designation application submitted by Trelleborg Sealing Solutions, Inc. and approved under Confirming Resolution R-32-10 was for \$589,907 in real property improvements and \$290,000 in personal property distribution and information and technology improvements; and

**WHEREAS**, Trelleborg Sealing Solutions, Inc. indicated it would retain 320 full-time jobs with an annual payroll of \$15,089,000 and create 46 full-time jobs with an annual created payroll of \$1,657,000; and

**WHEREAS**, Trelleborg Sealing Solutions, Inc. did not initiate the schedule of phase-in for real property improvements following the approval of Confirming Resolution R-32-10; and

**WHEREAS**, Trelleborg Sealing Solutions, Inc. did initiate the schedule of phase-in for personal property improvements following the approval of Confirming Resolution R-32-10; and

**WHEREAS**, Trelleborg Sealing Solutions, Inc. did not file a 2023 Compliance with Statement of Benefits Personal Property (Form CF-1/Personal Property) with the City of Fort Wayne; and

**WHEREAS**, Trelleborg Sealing Solutions, Inc. has not provided communication to the City that they would not file a Compliance with Statement of Benefits Personal Property (Form CF-1/Personal Property); and

**WHEREAS**, the Common Council acknowledges that Trelleborg Sealing Solutions, Inc. did not file a 2023 CF-1/Personal Property and did not request a waiver of non-compliance which the Common Council has the power and authority to approve, under I.C. 6-1.1-12.1-9.5).

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

**SECTION 1.** That Trelleborg Sealing Solutions, Inc. failed to file a Compliance with Statement of Benefits Personal Property (Form CF-1/Personal Property) and failed to file for a waiver of non-

1 compliance for not filing said Compliance with Statement of Benefits Personal Property  
2 Improvements (Form CF-1/Personal Property) and as a result of said failure, the tax phase-in for  
3 Trelleborg Sealing Solutions, Inc. under R-32-10 is hereby terminated by Common Council. The  
4 Allen County Auditor and Allen County Assessor shall be supplied with a copy of this Resolution,  
upon passage, and is instructed to terminate the abatement for personal property improvements.

5 **SECTION 2.** That, this Resolution shall be in full force and effect from and after its passage and  
6 any and all necessary approval by the Mayor.
