3 A RESOLUTION OF THE COMMON COUNCIL OF
4 THE CITY OF FORT WAYNE AMENDING THE NOT-
5 TO-EXCEED AMOUNT OF A DEMOLITION
6 CONTRACT BETWEEN THE FORT WAYNE
7 REDEVELOPMENT COMMISSION AND AMOR
8 EXCAVATING FOR THE FORMER PEPSI
9 WAREHOUSE ON NORTH HARRISON STREET.

10 **WHEREAS**, on December 19, 2023, the Fort Wayne Common
11 Council ("Common Council") unanimously adopted Resolution R-23-12-13
12 approving the use of 2023 Supplemental LIT funds for a contract in the not-to-
13 exceed amount of Five Hundred Twenty-One Thousand Six Hundred Forty-One
14 and 95/100 Dollars (\$521,641.95) between the Fort Wayne Redevelopment
15 Commission ("Commission") and Amor Excavating for demolition of the former
16 Pepsi Warehouse located at 1207 North Harrison Street (the "Demolition"); and

17 **WHEREAS**, due to unforeseen circumstances the actual cost of the
18 Demolition exceeded the agreed-upon amount and therefore requires a change
19 order, attached hereto as Exhibit A, in the amount of One Hundred Fifty-Four
20 Thousand Three Hundred Sixty-Nine and 36/100 Dollars (\$154,369.36).

22 **NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE**
23 **CITY OF FORT WAYNE, INDIANA:**

24 **SECTION 1.** That the not-to-exceed construction contract amount
25 for the Demolition shall be Six Hundred Seventy-Six Thousand Eleven and 31/100
26 Dollars (\$676,011.31).

The time provided for final completion of this project on this contract changed by 63 calendar days due to this Change Order. The date for final completion of all work shall be 8/30/2024. Furthermore, this document shall become an amendment to the contract and all provisions of the contract shall apply hereto.

JUSTIFICATION FOR CHANGE:

Had extra landfill costs because we could not crush as much concrete as we thought because of restraints from State regulators. Added topsoil to help shape land better for drainage and removed a big area of unexpected concrete that was not part of the original building footprint but within the project area.

DEPARTMENT REQUESTING RESOLUTION. Redevelopment

SYNOPSIS OF ORDINANCE. On December 19, 2023, the Common Council unanimously adopted Resolution R-23-12-13, approving the use of 2023 Supplemental LIT funds for a contract not to exceed \$521,641.95 between the Fort Wayne Redevelopment Commission and Amor Excavating. This contract is for the demolition of the former Pepsi Warehouse located at 1207 North Harrison Street.

The proposed amendment would increase the not-to-exceed amount by \$154,369.36, bringing the total to \$676,011.31.

EFFECT OF PASSAGE. The additional funding is necessary to address unforeseen conditions, primarily increased landfill costs. During demolition, State regulators required that painted concrete be characterized as industrial waste, preventing it from being crushed and reused locally. This necessitated special handling and disposal procedures. The amendment also covers the cost of added topsoil to improve drainage and the removal of unexpected concrete found outside the original building footprint but within the project area.

EFFECT OF NON-PASSAGE. Without approval, the Commission would not be authorized to pay Amor Excavating with funds that were budgeted for the project.

MONEY INVOLVED (DIRECT COSTS, EXPENDITURES, SAVINGS). The change order of \$154,369.36 will be drawn from the 2023 Supplemental LIT. The original contract amount was significantly lower than the estimated project cost, so sufficient budgeted funds are available to cover this amendment.

Subject: Amending the not-to-exceed amount for a Demolition Contract with Amor Excavating for the former Pepsi Warehouse at 1207 North Harrison Street.

The Department of Redevelopment formally requests Common Council approval for an amendment to the not-to-exceed amount of a demolition contract between the Fort Wayne Redevelopment Commission and Amor Excavating. This contract pertains to the 7-acre former Pepsi Warehouse located at 1207 North Harrison Street. The source of funds for the contract and the amendment is 2023 Supplemental LIT, which requires Council approval for its use.

The proposed amendment would increase the not-to-exceed amount by \$154,369.36, bringing the total to \$676,011.31. This increase is due to unforeseen conditions, including:

- **Additional landfill costs:** State regulators determined that painted concrete required special handling and disposal procedures. This accounts for the majority of the additional costs.
- **Added topsoil** to improve land grading for better drainage.
- **Removal of unexpected concrete** found outside the original building footprint but within the project area.

The demolition work is substantially complete. The original contract amount was significantly lower than the estimated project cost, so sufficient budgeted funds are available to cover this amendment.
