

3 A DECLARATORY RESOLUTION designating an “Economic  
4 Revitalization Area” under I.C. 6-1.1-12.1 for property  
5 commonly known as 6499 Welch Road, Fort Wayne, Indiana  
6 46804 (SDG Getz, LLC/Summit Real Estate Development  
7 Group LLC)

8 WHEREAS, SDG Getz, LLC/Summit Real Estate Development Group LLC (“Petitioner”)  
9 has duly filed its petition dated June 27, 2025 to have the following described property designated  
10 and declared an “Economic Revitalization Area” under Sections 153.13-153.24 of the Municipal  
11 Code of the City of Fort Wayne, Indiana, and I.C. 6-1.1-12.1, to wit:

12 Attached hereto as “Exhibit A” as if a part herein; and

13 WHEREAS, said project will create two full-time permanent jobs and one part-time jobs  
14 with an annual payroll of \$138,500; and

15 WHEREAS, the total estimated project cost is \$24,821,426; and

16 WHEREAS, it appears the said petition should be processed to final determination in  
17 accordance with the provisions of said Division 6.

18 NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF  
19 FORT WAYNE, INDIANA:

20 SECTION 1. That, subject to the requirements of Section 6, below, the property  
21 hereinabove described is hereby designated and declared an “Economic Revitalization Area”  
22 under I.C. 6-1.1-12.1. Said designation shall begin upon the effective date of the Confirming  
23 Resolution referred to in Section 6 of this Resolution and shall terminate on December 31, 2026,  
24 unless otherwise automatically extended in five year increments per I.C. 6-1.1-12.1-9.

25 SECTION 2. That, upon adoption of the Resolution:

- 26 (a) Said Resolution shall be filed with the Allen County Assessor;
- 27 (b) Said Resolution shall be referred to the Committee on Finance requesting a  
28 recommendation from said committee concerning the advisability of designating the  
29 above area an “Economic Revitalization Area”;
- 30 (c) Common Council shall publish notice in accordance with I.C. 6-1.1-12.1-2.5 and I.C.  
5-3-1 of the adoption and substance of this resolution and setting this designation as  
an “Economic Revitalization Area” for public hearing.

SECTION 3. That, said designation of the hereinabove described property as an  
“Economic Revitalization Area” shall apply to a deduction of the assessed value of real estate  
improvements to be made between August 1, 2025 and April 31, 2027. Should any delays occur,  
an updated timeframe will be communicated to the Allen County Assessor and Allen County Auditor  
by Community Development staff in writing.

1                   **SECTION 4.** That, the estimate of the number of individuals that will be employed or  
2 whose employment will be retained and the estimate of the annual salaries of those individuals and  
3 the estimate of the value of redevelopment or rehabilitation, all contained in Petitioner's Statement  
4 of Benefits submitted to the City of Fort Wayne, Indiana ("City") are reasonable and are benefits  
5 that can be reasonably expected to result from the proposed described redevelopment or  
6 rehabilitation.

7                   **SECTION 5.** That, the current year approximate tax rates for taxing units within the  
8 City would be:

- 9                   (a) If the proposed development does not occur, the approximate current year tax rates  
10 for this site would be \$2.9067/\$100.  
11                   (b) If the proposed development does occur and no deduction is granted, the approximate  
12 current year tax rate for the site would be \$2.9067/\$100 (the change would be  
13 negligible).  
14                   (c) If the proposed development occurs, the deduction schedule listed below in Section 8  
15 is assumed, the approximate current year tax rate for the site would be \$2.9067/\$100  
16 (the change would be negligible).

17                   **SECTION 6.** That, this Resolution shall be subject to being confirmed, modified and  
18 confirmed, or rescinded after public hearing and receipt by Common Council of the above  
19 described recommendations and resolution, if applicable.

20                   **SECTION 7.** That, pursuant to I.C. 6-1.1-12.1, it is hereby determined that the  
21 deduction from the assessed value of the hereinabove described real property shall be for a period  
22 of ten years.

23                   **SECTION 8.** The deduction schedule from the assessed value of the hereinabove  
24 described real property pursuant to I.C. 6-1.1-12.1-17 shall be:


26                   **SECTION 9.** That, the benefits described in the Petitioner's Statement of Benefits can

**WHEREAS**, said project will create two full-time permanent jobs and one part-time jobs with an annual payroll of \$138,500; and

**WHEREAS**, the total estimated project cost is \$24,821,426; and

**WHEREAS**, a recommendation has been received from the Committee on Finance; and

**WHEREAS**, notice of the adoption and substance of said Resolution has been published in accordance with I.C. 6-1.1-12.1-2.5 and I.C. 5-3-1 and a public hearing has been conducted on said Resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:**

**SECTION 1.** That, the Resolution previously designating the above described property as an “Economic Revitalization Area” is confirmed in all respects.

**SECTION 2.** That, the hereinabove described property is hereby declared an “Economic Revitalization Area” pursuant to I.C. 6-1.1-12.1, said designation to begin on the effective date of this Resolution and shall terminate on December 31, 2026, unless otherwise automatically extended in five year increments per I.C. 6-1.1-12.1-9.

**SECTION 3.** That, said designation of the hereinabove described property as an “Economic Revitalization Area” shall apply to a deduction of the assessed value of real estate improvements to be made between August 1, 2025 and April 31, 2027. Should any delays occur, an updated timeframe will be communicated to the Allen County Assessor and Allen County Auditor by Community Development staff in writing.
