She is Director of Entrepreneur Initiatives at the Northeast Indiana Innovation Community. A former role was Executive Director at The Reclamation Project. At The Reclamation Project she contributed to refugee and immigrant advocacy, housing projects, and broader community development.

Angie is a long-time homeowner in the Shawnee Place Local Historic District.
