4 **RESOLUTION ESTABLISHING ANNUAL**
5 **HOLIDAY FOR CITY EMPLOYEES**

6 **Whereas**, the Common Council of the City of Fort Wayne ("Council") and
7 the City Administration wish to establish an annual holiday to be observed by the
8 City of Fort Wayne ("City") for the benefit of City employees; and

10 **Whereas**, the holiday shall be designated annually by the Mayor.

11 **NOW THEREFORE BE IT RESOLVED BY THE COMMON COUNCIL OF**
12 **THE CITY OF FORT WAYNE, INDIANA:**

13 **Section 1.** Commencing in calendar year 2025, the Holiday Schedule to
14 be observed by the City of Fort Wayne shall include, in addition to the eleven
15 (11) current holidays, an additional annual holiday that shall be designated each
16 year at the discretion of the Mayor.

17 **Section 2.** The Mayor has designated December 26, 2025 as the annual
18 holiday for the 2025 calendar year.

19 **Section 3.** This benefit shall not apply to employees of the City covered
20 under a collective bargaining agreement.

21 **Section 4.** That this resolution shall be in full force and effect from and
22 after its passage and any and all necessary approval by the Mayor.
