WHEREAS, adequate funds exist in certain series of the Fort Wayne Public Transportation Corporation; and

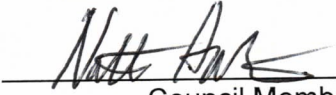
WHEREAS, such transfers have been recommended by the City Controller.

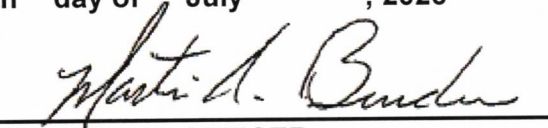

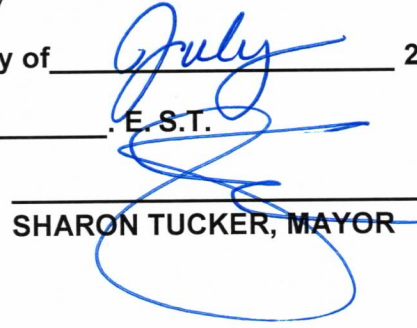

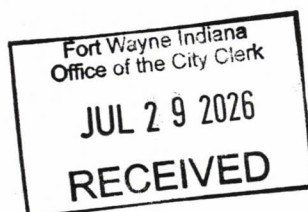
