17 involving a total cost of FOUR HUNDRED FORTY-FIVE THOUSAND, TWO
18 HUNDRED AND NO/100 DOLLARS - (\$445,200.00) all as more particularly set
19 forth in said ITB #3263 - ANNUAL REQUIREMENTS FOR THE PURCHASE
20 OF LIQUID FERRIC SULFATE which is on file in the Office of the Department
21 of Purchasing, and is by reference incorporated herein, made a part hereof,
