SPECIAL ORDINANCE NO. S-20-11

AN ORDINANCE approving CONSULTING CONTRACT for the Auburn Road: Clinton Street to Cook Road Project: WO# 11848 between ENGINEERING TECHNOLOGIES INC. and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

WHEREAS, the Board of Public Works desires to hire a consultant for professional construction engineering and inspection services for the Auburn Road: Clinton Street to Cook Road Project: WO# 11848; and

WHEREAS, the City of Fort Wayne does not have the capability of performing this work with in-house forces; and

WHEREAS, it is anticipated that the amount to be paid to said Consultant, on an annual basis, will not exceed FOUR HUNDRED SIXTY-FOUR THOUSAND, SIX HUNDRED THIRTY-SEVEN AND 68/100 DOLLARS - (\$464,637.68).

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the CONSULTING CONTRACT for the Auburn Road: Clinton Street to Cook Road Project: WO# 11848 by and between ENGINEERING TECHNOLOGIES INC. and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects. A copy said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.


