SPECIAL ORDINANCE NO. S-30-11

AN ORDINANCE approving CONSTRUCTION CONTRACT FOR THE EWING STREET STORM SEWER EXTENSION: RES. #2305-2010, W.O. #75463 between CROSBY EXCAVATING, INC. and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the CONSTRUCTION CONTRACT FOR THE EWING STREET STORM SEWER EXTENSION: RES. #2305-2010, W.O. #75463 by and between CROSBY EXCAVATING, INC. and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for Ewing Street Storm Sewer Extension as follows: The Ewing St. Sewer Separation project consists of the construction of a new storm sewer ranging in size from 60" to 72" from just north of the intersection of Wayne St. and Ewing St. to the St. Mary's River along Ewing St.;

involving a total cost of ONE MILLION, SIX HUNDRED TEN THOUSAND, NINETY-ONE AND 80/100 DOLLARS - (\$1,610,091.80).

SECTION 2. Prior Approval has been requested from Common Council on DECEMBER 14, 2010. Said copy is on file in the Office of the City Clerk and made available for public inspection, according to law.
