SPECIAL ORDINANCE NO. S-28-11

AN ORDINANCE approving CONSULTING CONTRACT for THE LAKE AVENUE ROAD DIET - ANTHONY BLVD. TO STANLEY AVENUE: W.O. #12180 between ENGINEERING TECHNOLOGIES, INC. and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

WHEREAS, the Board of Public Works desires to hire a consultant for professional preliminary engineering services for the project - THE LAKE AVENUE ROAD DIET - ANTHONY BLVD. TO STANLEY AVENUE: W.O. #12180; and

WHEREAS, the City of Fort Wayne does not have the capability of performing this work with in-house forces; and

WHEREAS, it is anticipated that the amount to be paid to said Consultant, on an annual basis, will not exceed ONE HUNDRED TWENTY THOUSAND, FIFTY AND NO/100 DOLLARS - (\$120,050.00) (90% FEDERAL, 10% LOCAL).

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the CONSULTING CONTRACT for the for THE LAKE AVENUE ROAD DIET - ANTHONY BLVD. TO STANLEY AVENUE: W.O. #12180 by and between ENGINEERING TECHNOLOGIES, INC. and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects.
