AN ORDINANCE approving CIPP 2010 SMALL DIAMETER PACKAGE #3: RES. #2316-2010 - WO #75450 between INSITUFORM and the City of Fort Wayne, Indiana, in connection with the Board of Public Works.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF FORT WAYNE, INDIANA:

SECTION 1. That the CIPP 2010 SMALL DIAMETER PACKAGE #3: RES. #2316-2010 - WO #75450 by and between INSITUFORM and the City of Fort Wayne, Indiana, in connection with the Board of Public Works, is hereby ratified, and affirmed and approved in all respects, respectfully for:

All labor, insurance, material, equipment, tools, power, transportation, miscellaneous equipment, etc., necessary for Rehabilitation of approximately 31,365 LF of small diameter (8-inch to 15-inch) sanitary sewer by means of a cured-in-place pipe method;


involving a total cost of ONE MILLION, SEVENTEEN THOUSAND, FOUR HUNDRED FORTY-THREE AND NO/100 DOLLARS - (\$1,017,443.00). A copy said Contract is on file with the Office of the City Clerk and made available for public inspection, according to law.
